WHEREAS pursuant to Part 15 of the *Local Government Act*, R.S.B.C. 1996, c.323 as amended (the "*Act*"), and the regulations passed pursuant thereto, the Council of the City of Surrey may, by bylaw, operate a service that the Council considers necessary or desirable for all or part of the municipality;

WHEREAS the Council of the City of Surrey has determined that it is necessary for the City to construct and operate storm drainage systems for the convenience and safety of the residents and businesses within the City;

WHEREAS Section 360 of the *Act* allows the imposition of a parcel tax on all properties within the City, to fund all or part of the cost of constructing and operating the service;

NOW THEREFORE, the City Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

- 1. This by-law may be cited for all purposes as "Surrey Drainage Parcel Tax By-law, 2001, No. 14593."
- 2. A parcel tax in the amount and for the years specified in Schedule "A" is hereby imposed upon the owners of all land or real property in the City of Surrey.
