A by-law to amend the provisions of "Surrey

The Council of the City of Surrey, in open meeting assembled, ENACT AS FOLLOWS:

1. "Surrey Electrical Safety By-law, 2004, No. 15596," as amended is hereby further amended as follows:
 - (a) Schedule B, is amended by replacing the existing schedule B rates with the "Proposed Fee's" listed as per the attached schedule.
2. This By-law shall be cited for all purposes as "Surrey Electrical Safety By-law, 2004, No. 15596, Amendment By-law, 2012, No. 17559".

SCHEDULE "B" TO ELECTRICAL SAFETY BY-LAW, 2004, NO. 15596

ELECTRICAL PERMIT FEES

Installation Permits

Fees for installation permits are based on the value of the electrical installation, including all material and labour and fees for design, testing, consulting, and monetary worth of contributed labour and materials. The Marshall Swift valuation service may be used to establish the value of an electrical installation.

Permit fees for homeowner permits are based on a deemed installation value of three times the cost of materials.

Electrical Permit fees will be divided into two (2) portions. Ten (10%) percent of the estimated Electrical Permit Fee will be deemed applicable to plan checking and ninety (90%) percent of the estimated Electrical Permit fee will be deemed applicable to inspection charges. Where one or more letters of assurance from a registered professional are required, the plan checking amount will be reduced by ten (10%) percent to a maximum deduction of Five Hundred (\$500) Dollars.

7. Special Inspections

Where an applicant wishes a special inspection not provided for in the fee schedule, the fee shall be:

(a) during normal working hours	\$73.00 [one hour minimum]	\$75.00 [one hour minimum]
(b) after hours during which the offices of the City Hall are normally open, the fee, in addition to other required fees, to be based on the time actually spent in making such inspection, including travelling time.	\$503.00 plus \$125.00 per hour for each hour or part thereof beyond 4 hours	\$518.00 plus \$129.00 per hour for each hour or part thereof beyond 4 hours
