

CITY OF SURREY  
BY-LAW NO. 17569

A by-law to amend the provisions of "Surrey  
Tree Protection By-law, 2006, No. 16100,"  
as amended.

The Council of the City of Surrey, in open meeting assembled, ENACT AS FOLLOWS:

1. "Surrey Tree Protection By-law, 2006, No. 16100," as amended is hereby further amended as follows:

- (1) Section 36 is amended by replacing the "SIXTY-THREE (\$63.00) DOLLAR base fee plus TWENTY-FOUR (\$24.00) DOLLARS" with "SIXTY-FIVE (\$65.00) DOLLAR base fee plus TWENTY-FIVE (\$25.00) DOLLARS".
- (2) Section 37 is amended by deleting the Zone and Lot Size table and replacing it with the following Zone and Lot Size table:

- (4) Section 39 is amended by deleting the Zone Designation table and replacing it with the following Zone Designation table:

- (5) Section 40 is amended by replacing the "SIXTY-NINE (\$69.00) DOLLARS" amount with "SEVENTY-ONE (\$71.00) DOLLARS".

(6) Section 71 is amended by replacing the "EIGHTY-FIVE (\$85.00) DOLLARS" amount with "EIGHTY-EIGHT (\$88.00) DOLLARS".

2. This By-law shall be cited for all purposes as "Surrey Tree Protection By-law, 2006, No. 16100, Amendment By-law, 2012 No. 17569".
