BYLAW NO. 19337

A Bylaw to remove the park reservation of a portion of
Hawthorne Park in the City of Surrey.

WHEREAS pursuant to Section 30 of the *Community Charter*, S.B.C. 2003, c. 26,
the Council may, by bylaw, remove a reservation for a particular municipal or other public
purpose from real property owned by the municipality;

AND WHEREAS pursuant to Section 30(3) of the *Community Charter*, S.B.C. 2003, c. 26, the bylaw
may only be adopted with the approval of the electors;

AND WHEREAS by separate bylaw Council is reserving or dedicating additional park land to
expand the area of Hawthorne Park;

NOW THEREFORE the Council of the City of Surrey, ENACTS as follows:

1. The reservation for park purposes of those lands described as follows:
