

Town Hall
February 29th 1896

Council met pursuant to adjournment from
Reve Armstrong, Councillors Wiggridge, Cameron,
Keery, Burnett, and Hardy. minutes of previous
meeting were read and confirmed after making a
slight change in the 25th line on the last page.
Communications were read as follows.

- From the Hon Jas. Baker provincial secretary acquainting
this Council that the government feel that the work of
constructing a bridge over the Fraser river at present, to
heavy an expenditure to undertake. placed on file
- From the Canadian N.W. Immigration Convention - placed on file
- From D. Robson Sec Board of Trade giving notice of setting of Board
received to date to be acted upon
- From E. A. Wyle approving of Loan by - law Filed
- From Alex McRae re road ditch along his ranch on the west side
- From G. F. Bonson referring to the building of the Hall's Prairie
road in 1877. That, whatever original stakes were there
then, than were none removed by him, as it was
an established rule not to remove any stakes. placed on file
- From George Boothroyd enclosing a petition re bridge on the Serpentine
river.
- From James McCallum asking permission to raise the bridge
on the K & Mc Bay road so as to allow of logs passing under
permission granted
- From H. H. Hawkins C.M.C. Langley re Union Board of
Health. filed
- A Petition from Geo Boothroyd and others asking
that a bridge be built over the Serpentine river on the Boothroyd
road.
- From H. A. Estlin enclosing auditors report
for 1895 also his bill Report received.

Orders for work on the C. V. Road were opened and after
discussion, on motion of Geo Keery second by Geo Cameron laid over
until next meeting to be carried

 That Mr Mc Callum be authorized to raise
 the bridge on the K. & M Bay road, subject to Co Keery's
 approval

 meeting

 Co Burnett be authorized to call for tenders
 for necessary work to be done on the New Town
 road in cutting ditches and clearing road

Moved by Co Moggridge second Co Hardy that the clerk
 have the Auditor's statement published in the weekly
 Columbian along with the first part of his accompanying
 report omitting his recommendations of the expense be not
 excessive

Moved by Co Keery second by Co Cameron That Co Keery
 be allowed to have 20 rods of corduroy laid on the
 clover valley road south of the bridge tenders to be
 in at next meeting of council

Moved by Co Hardy second by Co Moggridge That
 the Reeve be delegated to confer with the Council of
 Langley re the formation of a union board of health
 and appointment of a medical health officer in
 accordance with the Medical Health act, with power
 to appoint Co Cameron to act in his stead if required

Moved by Co Cameron second by Co Burnett That the
 Municipal Constable be paid for 2 Days @ \$3 per day.

Moved by Geo Hardy second by Co Keery That Geo McKenzie be refunded the sum of six dollars overcharged Statute labor for 1893

Moved by Co Burnett second by Co Hardy That the order of W.B. Springs to J.R. Shephard for work on Centret Township line ward 2 be accepted

Moved by Co Burnett second by Co Keery That the sum of \$6 Dollars spent by Com Cameron over the amount appropriated on the line road ward one be approved

Moved by Co Cameron second by Geo Wiggidge That Com Cameron be authorized to call for tenders for cutting out the Coast Meridian road north from the gale road tender to be in at next meeting of council

Com Hardy gave notice That he would bring in a by-law amending the Statute labor by-law at next meeting

Com Burnett was granted further time to prepare and bring in a tax sale by-law.
