Contractors are advised that Addendum No. 1 to RFQ 1220-040-2017-120 is hereby issued by the City. This addendum shall form part of the Contract Documents and is to be read, interpreted and coordinated with all other parts. The following information is provided to answer questions raised by Contractors for the above named project, to the extent referenced and shall become a part thereof. No consideration will be allowed for extras due to the Contractor or any sub-contractor not being familiar with this addendum. This Addendum No. 1 contains 12 pages in total.


QUESTIONS & ANSWERS:

- Q1: Schedule A 5.2A States Base schedule of 10 times per year. But then schedule A-2 (c) states 15 cuts not including optional. What are the frequencies, and the proposed cutting dates?
- A1: This reference is for RFQ-1220-040-2018-005. It should be 15 cuts per year.
- Q2: Schedule A-2 (a) Also states every 2 weeks but (d) states weekly for optional cuts which is it?


A2: Base price is bi-weekly and options may be weekly, should the City decide to change the schedule to weekly.

- Q3: Schedule A (4.1) Are optional cuts billable to the city as per standard rates per cut or per Sqm? This question also refers to all other grass cutting tenders out.
- A3: Please refer to Schedule B, Section B-2-1 Optional Alternative Cut Schedule Prices.

- Q4: It appears that the attachment for the detention ponds is the same as the attachment for South Surrey mowing King George. Is there details on the detention ponds, which can be updated?
- A4: Please see the attached Tutorial for using COSMOS. Details can be found in COSMOS.
- Q5: KGB SW 8-16 Do we cut the street side of the ditch only or do we also cut the slope and top of the slope?
- A5: This reference is for RFQ-1220-040-2018-006. KGB reference is in Map pages 010,011,012. When the aerial map is shown in COSMOS the defined area is shown in detail as to their relation to sidewalks, frontages, lot lines etc. Mowing with the exception of the bottom ditches shall be considered the contract area. Areas shall be cut as practicable to the edge of the slope.
- Q6: For all the remaining boulevards for KGB 10-32 do we mow up to the property fences and/or telephone poles?
- A6: This reference is for RFQ-1220-040-2018-006. KGB is only in Map pages 010, 011, 012, 021,022, 031,032. When the aerial map is shown in COSMOS the mowing area is shown in detail as to their relation to sidewalks, frontages, poles, lot lines etc. The colored area is schematic in all cases shall define the limits of cutting. Details will be further explained after tender award.
- Q7: Where there are ditches along the boulevards along KGB 10-32 do we only mow the road side of the ditch or both sides?
- A7: This reference is for RFQ-1220-040-2018-004. Where access permits both sides of the ditches shall be mowed. The contractor shall have the appropriate equipment available to access both sides when & where required.
- Q8: Are we required to cut inside the ditches?
- A8: This reference is for RFQ# 1220-040-2018-003, 1220-040-2018-005, 1220-040-2018-006 and 1220-040-2017-120. Mowing with the exception of the bottom of ditches shall be considered the contract area. Areas shall be cut as practicable to the edge of the slopes.
- Q9: Where there are sidewalks along KGB 10-37 do we only mow the street side of the sidewalks?
- A9: This reference is for RFQ-1220-040-2018-006. KGB is only in Map pages 000, 001,010,011,012,021,022,031,032. When the aerial map is shown in COSMOS the defined area is shown in detail as to their relation to sidewalks, frontages, lot lines etc. Mowing with the exception of ditches shall be considered the contract area. Areas shall be cut as practicable to the edge of the slopes.
- Q10: Should KGB W 44-46 Ave be E rather than W?
- A10: The reference is to the West side of King George between 44 Avenue and 46 Avenue, please see below.




- Q11: Is 4218 KGB E the bus stop area?






