THE CORPORATION OF THE DISTRICT OF SURREY

BY-LAW NO. 10119

A by-law to dispose of portions of a public highway in exchange for adjoining lands necessary for a public highway.

.....

WHEREAS the Corporation of the District of Surrey is the owner of the land described in Section 2 of this By-law and has agreed to make the exchange hereinafter provided for;

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

- 1. Upon receiving from the said Corporation of the District of Surrey the conveyance or other assurance mentioned in Section 2 hereof, the Mayor and the Clerk of The Corporation
 - of the District of Surrey are hereby authorized, in exchange
 - therefore, to execute and deliver on behalf of The Corporation such conveyance or other assurance as may be necessary for vesting in the Corporation of the District of Surrey for park purposes, ALL AND SINGULAR those certain parcels or tracts of land and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia as follows:

Those portions of road in Section Fifteen (15), Township One (1), dedicated by Plan Eleven Thousand Six Hundred Forty-Five (11645), New Westminster District, shown hatched on reference plan attached hereto, prepared by K.T. Naylor, B.C.L.S., on March 27, 1989, and described as follows:

That portion of road containing Three Thousand Two Hundred Eight (3208) square metres (shown as Parcel Two (2));

That portion of road containing Three Thousand Two Hundred Six (3206) square metres (shown as Parcel Three (3));

That portion of road containing Four Thousand Nine Hundred Ninety-Two (4992) square metres (shown as Parcel Four (4)).

(Portions of 18A, 19 & 19A Avenues, between 146 and 148 Streets)

2. For the purpose of acquiring adjacent lands for a public highway, The Mayor and Clerk are authorized to accept

from the Corporation of the District of Surrey, in exchange for the land mentioned in Section One (l) hereof, the sum of One Dollar (\$1.00), together with such conveyance or other

assurance as may be necessary to vest in the Crown as a public highway, ALL AND SINGULAR those certain parcels or tracts of lands and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia:

Those portions of Section Fifteen (15), Township One (1), New Westminster District, shown within heavy outline on reference plan attached hereto, prepared by K.T. Naylor, B.C.L.S., on March 27, 1989, and described as follows:

That portion of Block Five (5), Plan Eleven Thousand Six Hundred Forty-Five (11645), containing Six Hundred Fifty and Three-Tenths (650.3) square metres (shown as Parcel "A");

(Part of 1935 - 148 Street)

That portion of Block Twelve (12), Plan Eleven Thousand Six Hundred Forty-Five (11645), containing Six Hundred Forty-Nine and Nine-Tenths (649.9) square metres (shown as Parcel "B");

(Part of 1891 - 148 Street)

That portion of Parcel "C", Plan Twenty-Three Thousand Six Hundred Three (23603), containing Five Hundred Eighty-Three (583.0) square metres (shown as Parcel One (1));

That portion of Parcel "C", Plan Twenty-Three Thousand Six Hundred Three (23603), containing One Hundred Eight-Nine and Six-Tenths (189.6) square metres (shown as Parcel Five (5)).

3. This By-law may be cited for all purposes as "18A/148 Street Road Exchange By-law, 1989, No. 10119."
