 were read and dealt with as follows:-

- From H. Bone, Hon Secy & B.C.M. saying the postponed annual
 meeting of the Union would be held in the City of North-
 Vancouver Thursday Dec 16th commencing at 2.30 P.M.,
 and that in the event of the municipality having any
 matter they wished placed before the convention to please
 a copy to the Secretary so that the same may be placed in
 the order of business, Recd.
- From A H MacNeill re White-Rock Road saying the matter had
 been overlooked but that he was writing for a cheque to
 close the matter out, Recd.
- From John A Thomas asking the Council for assistance in
 building a road from the Hunt-Road to Block 12 of the
 Subd A W 74 Sec 19 T4 R2. that he had slashed and graded
 20 chains of it and would like to corduroy the bad places
 and hoping the Council would grant some assistance,
 Recd + referred to Coun Murphy,
- From H W Bonson saying the ditch in front of his place was
 filled with sand which seemed to have washed down from
 the B.C.E.Ry grade, and requesting that it be cleaned
 out, Recd and referred to Co Murphy,
- From L M Robertson, saying that in consequence of the grading
 of the Coase Meridian Road north of his house, and the
 subsequent clearing out of the ditched last summer
 which removed the dams put in to keep the water in
 its natural course, his meadow had been submerged,
 and saying half a days work with one team would put the
 matter right, and that he hoped to save trouble & expense.
 the Council will give orders to have the matter put right at
 once, Recd and referred to Co Loucks,

From L. Hamilton re bad condition of Bon Accord Road. Resd and referred to Co Loucks,

L. W. Davis at Lynnhed Public Hall, G. S. Fife at ~~new Hall~~ ^{G. S. Fife's house} Lattimer Road ward 1, Jos. Drunkwater ward 2, John Loney Mud Bay school house and Joshua Williams Scott Road school house ward 3, and Alben Bamford ward 5, all at the usual remuneration, and that notice of the election be advertised by one insertion in the Columbian and by posting at the door of the Town Hall, carried,
