

CITY OF SURREY

BY-LAW NO. 12953

A by-law to acquire lands by expropriation for the purpose
of road widening.

.....

WHEREAS the Council of the City of Surrey has found it necessary to acquire the within
described property for the purpose of road widening;

AND WHEREAS pursuant to Section 578 of the "Municipal Act" of the Province of British
Columbia, the City Council may by by-law establish a highway or any portion of a highway;

AND WHEREAS pursuant to Section 578(3) of the "Municipal Act" of the Province of British
Columbia, the City Council may acquire property by expropriation and have free entry thereon;

NOW, THEREFORE, the Council of the City of Surrey, in open meeting assembled, ENACTS
AS FOLLOWS:

1. Pursuant to Section 578(3) and subject to Division 4 of PART XII of the "Municipal Act"
of the Province of British Columbia, the Council of the City of Surrey is hereby
authorized to enter upon, expropriate, break up, take and enter into possession of and use
for the purpose of road widening, ALL AND SINGULAR that certain parcel or tract of
land and premises situate, lying and being in the City of Surrey in the Province of British
Columbia and being:

All that portion of Lot 1, District Lot 3, Group 2, New
Westminster District, Plan 10616 as shown in heavy outline
on a Reference Plan attached hereto and containing 692
square metres.

(Portion of 11016 Bridge Road)

2. The Mayor and Clerk are hereby authorized to sign and seal all documents necessary and
incidental to effect such expropriation.

3. This By-law shall not come into effect until a certified copy of the By-law has been filed in the Land Titles Office in the City of New Westminster, and a Notice of Expropriation has been served on the registered owners of the land.

4. This By-law may be cited for all purposes as "Portion of 11016 Bridge Road Expropriation By-law, 1996, No. 12953."

PASSED THREE READINGS on the 28th day of October, 1996.

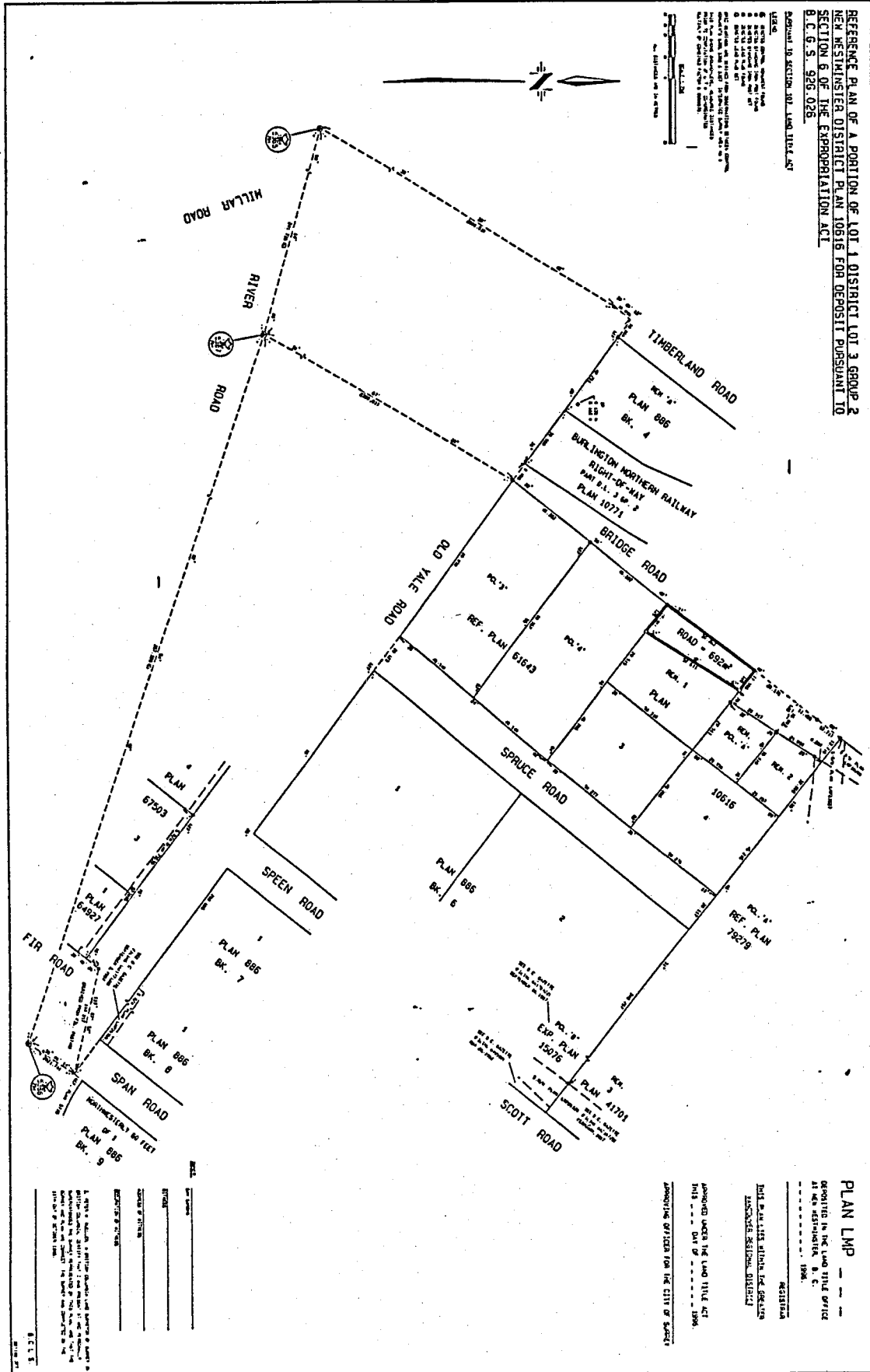
