WHEREAS the Council of the City of Surrey has found it necessary to acquire the within described property for the purpose of a Statutory Right-of-Way;

NOW, THEREFORE, the Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Pursuant to Section 578(3) and subject to Division 4 of PART XII of the "Municipal Act" of the Province of British Columbia, the Council of the City of Surrey is hereby authorized to enter upon, expropriate, break up, take and enter into possession of and use for the purpose of a Statutory Right-of-Way, ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the City of Surrey in the Province of British Columbia and being:

All that Portion of the North Half of the North West Quarter Section 6, Township 8, Except: Firstly: Part on Plan 22160; Secondly: Parcel "A" (Reference Plan 1337); Thirdly: Parcel "One" (See E26880), New Westminster District shown as Statutory Right-of-Way as outlined in heavy bold line on a Reference Plan attached hereto and forming a part of this By-law as Schedule A, and containing 1.62 hectares.

(Northerly Portion of 5490 - 168 Street)

2. The Mayor and Clerk are hereby authorized to sign and seal all documents necessary and incidental to effect such expropriation.
