BY-LAW NO. 13992

An Expropriation by-law for the purpose of acquiring a Statutory
Right-of-Way

.....

WHEREAS the Council of the City of Surrey has found it necessary to acquire the within
described property for the purpose of Statutory Right-of-Way;

AND WHEREAS pursuant to Section 527(1) of the *Municipal Act*, R.S.B.C. 1996, c. 323, as
amended, the City Council may by by-law authorize the establishment, widening, alteration,
relocation or diversion of a highway or any portion of a highway, including a sidewalk;

AND WHEREAS pursuant to Section 309 of the *Municipal Act*, R.S.B.C. 1996, c.323, as
amended, the City Council may acquire property by expropriation and have free entry thereon;

NOW, THEREFORE, the Council of the City of Surrey, in open meeting assembled, ENACTS
AS FOLLOWS:

1. Pursuant to Section 309 of the *Municipal Act*, R.S.B.C. 1996, c. 323, as amended, the
Council of the City of Surrey hereby authorizes the expropriation of a Statutory Right-of-
Way for the purpose of constructing, extending, altering, replacing, repairing, upgrading,
installing, protecting, clearing, flooding, maintaining, operating and servicing a sidewalk
in, over, upon and under ALL AND SINGULAR that certain parcel or tract of land
premises situate, lying and being in the City of Surrey in the Province of British
Columbia and being:

Parcel Identifier: 001-927-779

That portion of Parcel "A" (Explanatory Plan 14505) of Lots 1 and 2

Except: Part on Statutory Right-of-Way Plan 53884; Section 30 Township 2

New Westminster District Plan 1607 outlined on Statutory Right-of-Way Plan

LMP45369 containing 168 square metres.

(Portion of 8748 - 120 Street)

2. The Mayor and Clerk are hereby authorized to sign and seal all documents necessary and incidental to effect such expropriation.
3. This By-law may be cited for all purposes as "Portion of 8748 - 120 Street Expropriation By-law, 2000, No. 13992".
4. This By-law comes in to full force and effect on the date of final adoption.

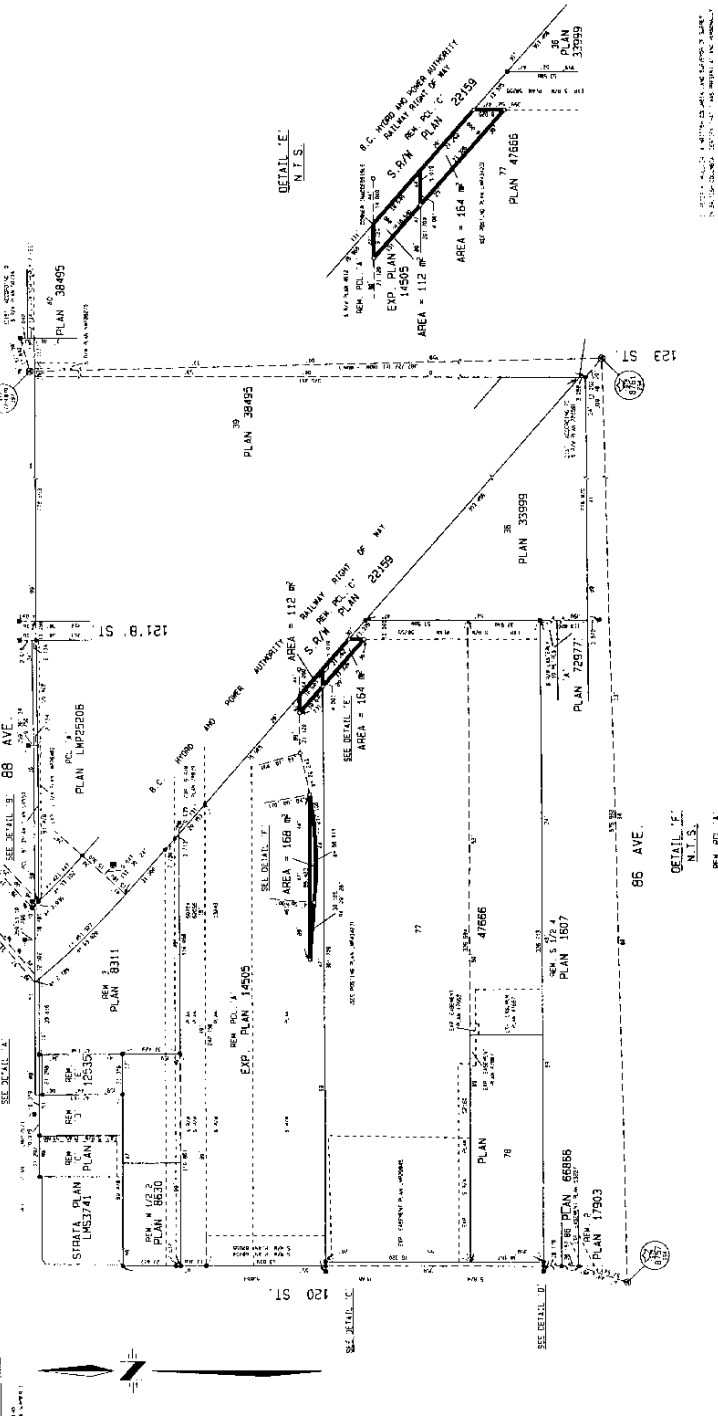
STATUTORY RIGHT OF WAY PLAN OF PORTIONS OF SECTION 30
