## BY-LAW NO. 15093

An Expropriation by-law for the purpose of acquiring a temporary Statutory Right-of-Way
WHEREAS the Council of the City of Surrey has found it necessary to acquire the within described property for the urpose of temporary Statutory Right-of-Way;
ND WHEREAS pursuant to Section 176(1)(d) of the <i>Local Government Act</i> , R.S.B.C. 1996, c. 323, as amended, the lity Council may acquire, hold, manage and dispose of land, improvements, personal property or other property, and my interest or right in or with respect to that property;
ND WHEREAS pursuant to Section 309 of the <i>Local Government Act</i> , R.S.B.C. 1996, c.323, as amended, the City douncil may, for the purpose of exercising or performing its powers, duties and functions, expropriate real property or works, or an interest in them, in accordance with the <i>Expropriation Act</i> , R.S.B.C. 1996, c. 125, as amended;
OW, THEREFORE, the Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:
Pursuant to Section 309 of the <i>Local Government Act</i> , R.S.B.C. 1996, c. 323, as amended, and for the construction, extension, alteration, replacement, repair, upgrading, installation, protection, clearing, maintenance, operation, carrying out, use and servicing of road works and related appurtenances, the Council of the City of Surrey hereby authorizes the expropriation of a temporary Statutory Right-of-Way in, over and upon ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the City of Surrey in the Province of British Columbia and more particularly described as:
That portion of Lot 86 Except: Part Dedicated Road on Plan BCP6107A, Block 3, Section 36, Block 5 North, Range 3 West, New Westminster District Plan 529A (Parcel Identifier: 011-840-251) shown as Statutory Right-of-Way outlined on Statutory Right-of-Way Plan BCP6108 containing 78.0 square metres.
(Portion of 9727 – 120 <sup>th</sup> Street)
The Mayor and Clerk are hereby authorized to sign and seal all documents necessary and incidental to ffect such expropriation.
This By-law may be cited for all purposes as "Portion of 9727 – 120 <sup>th</sup> Street Expropriation By-law, 2003, No. 15093".
This By-law comes in to full force and effect on the date of final adoption.
