WHEREAS the Council of the City of Surrey has found it necessary to acquire, in fee simple, the within described property for highway purposes;

AND WHEREAS pursuant to Section 8(1) of the *Community Charter*, S.B.C. 2003, c. 26, as amended, the City Council has the capacity, rights, powers and privileges of a natural person of full capacity and may acquire, hold, manage and dispose of land, improvements, personal property or other property, and any interest or right in or with respect to that property;

AND WHEREAS pursuant to Sections 31 & 32 of the *Community Charter*, S.B.C. 2003, c.26, as amended, the City Council may, for the purpose of exercising or performing its powers, duties and functions, expropriate real property or works, or an interest in them, in accordance with the *Expropriation Act*, R.S.B.C. 1996, c.125, as amended;

NOW, THEREFORE, THE Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Pursuant to Sections 31 & 32 of the *Community Charter*, S.B.C. 2003, c.26, as amended, the Council of the City of Surrey hereby authorizes the expropriation of certain lands in fee simple for highway purposes being ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the Township of Langley in the Province of British Columbia and more particularly described as:

That portion of Lot 1, Section 15, Township 8, West, New Westminster District Plan 18534 (Parcel Identifier: 000-908-541) being 61.2 square meters and outlined on Reference Plan BCP22185

(Portion of 6734 – 196th Street, Langley, B. C.)

- 2. The Mayor and Clerk are hereby authorized to sign and seal all documents necessary and incidental to effect such expropriation.
- 3. This By-law may be cited for all purposes as "Portion of 6734 196th Street, Langley, B.C. Expropriation By-law, 2006, No. 16034".
- 4. This By-law comes in to full force and effect on the date of final adoption.
