## BY-LAW NO. 15383

A by law to amend provisions of "681514 B.C. Ltd. Housing Agreement Authorization By law, 2004, No. 15272"

- 2. The Mayor and Clerk are hereby empowered to execute the Housing Amendment Agreement on behalf of the City of Surrey.
- 3. The City of Surrey shall file in the Land Title Office a notice against the Lands in accordance with Section 905 of the <u>Local Government Act</u>, that the Lands are subject to the Housing Amendment Agreement.
- 4. This By law shall be cited for all purposes as "681514 B.C. Ltd. Housing Agreement", Authorization By-law, 2004, No. 15272, Amendment By law, 2004, No. 15383."
