THE CORPORATION OF THE DISTRICT OF SURREY BY-LAW NO. 1934

As amended by By-law No. 2031

A By-law to authorize the construction, operation and maintenance of sewerage works in and for the special benefit of a portion of the Municipality and to authorize the borrowing of the sum of One Million Three Hundred Thousand Dollars (\$1,300,000.00) for construction of the said works.

WHEREAS it is deemed desirable and expedient to construct, operate and maintain sewerage works for the use of that portion of The Corporation of the District of Surrey herein defined (hereinafter referred to as "Surrey Sewerage Area No. 1"), and such works will be for the special benefit of said area:

AND WHEREAS the estimated cost of the works to be carried out under this By-law is the sum of \$1,300,000.00;

AND WHEREAS a permit has been granted by the Pollution Control Board:

AND WHEREAS a provisional certificate of approval of the sewerage works hereby authorized has been received from the Provincial Health Officer;

AND WHEREAS the amount of the debt which this By-law is intended to create is the sum of One Million Three Hundred Thousand Dollars (\$1,300,000.00) arrived at as follows:

Estimated Cost of sewerage works as hereinbefore recited \$1,235,000.00

Estimated expense of By-law, Debenture issue and contingencies 65,000.00

\$1,300,000.00

and the object for which said debt is created is the construction of sewerage works for "Surrey Sewerage Area No. 1";

AND WHEREAS the amount of assessed value for general Municipal purposes of

taxable land and improvements within the "Surrey Sewerage Area No. 1", according to the revised Assessment Rolls of The Corporation of the District of Surrey, being the Assessment Rolls for the years 1960 and 1961 was in 1960 \$10,400,200.00 and in 1961 \$11,624,089.00; and according to the unconfirmed Assessment Roll for the year 1962 is \$12,636,039.00.

AND WHEREAS the amount of the assessed value for general Municipal purposes of the taxable land and improvements within The Corporation of the District of Surrey, according to the revised Assessment Rolls of the said Corporation, being the Assessment Rolls for the years 1960 and 1961, was in 1960 \$108,548,629.00 and in 1961 \$118,640,532.00; and according to the unconfirmed Assessment Roll for the year 1962 is \$132,940,854.00;

AND WHEREAS the Corporation possesses a provisional certificate of self-liquidation granted by the Inspector of Municipalities in respect of its sewerage systems;

AND WHEREAS the depreciated value as at the thirty-first day of December, 1961, of the waterworks system for which the Municipality possesses a subsisting certificate of self-liquidation granted by the Inspector of Municipalities was \$4,658,854.16.

AND WHEREAS the amount of the existing debt of the Corporation is \$5,840,572.50 and none of the principal and interest is in arrears;

AND WHEREAS the approval of the Inspector of Municipalities has been obtained;

THEREFORE the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled, enacts as follows:

1. The portion of the Municipality for the special benefit of which the works hereby authorized to be constructed are undertaken and in this By-law referred to as "Surrey Sewerage Area No. 1" is defined as consisting of and comprising the lands within the following described boundaries, namely:

COMMENCING at the intersection of the North boundary of 114th Avenue (Markham Road) and the East boundary of 132nd Street (Roebuck Road);

Thence East along the North boundary of 114th Avenue (Markham Road) to the Westerly boundary produced of Block "E", Section Ten (10), Block Five (5) North, Range Two (2) West, Plan Twenty Thousand Three Hundred Forty-two (20342), New Westminster District;

Thence South following the Westerly boundary produced and the West boundary of said Block "E" to the North boundary of 112th Avenue (North Road);

Thence in a Southeasterly direction following the Easterly boundary of said Lot Thirteen (13) produced, the Easterly boundary and the Easterly boundary produced of said Lot Thirteen (13) to the Southerly boundary of Lot Twelve (12), Block One Hundred Thirty-seven (137), Port Mann Townsite, Plan Two Thousand Five Hundred Forty-six (2546), New Westminster District;

Thence in a Northeasterly direction following the Southerly boundary produced of said Lot Twelve (12) to the Northeasterly boundary of Park Drive;

Thence in a Southeasterly direction following the Northeasterly boundary of Park Drive to the Northerly boundary produced of Lot Seven (7), Block One Hundred Thirty-six (136), Port Mann Townsite, Plan Two Thousand Five Hundred Forty-six (2546), New Westminster District;

Thence in a Southwesterly direction along the Northerly boundary produced, the Northerly boundary and the Northerly boundary produced of said Lot Seven (7) to the Westerly boundary of Lot Nine (9), Block One Hundred Thirty-six (136), Port Mann Townsite, Plan Two Thousand Five Hundred Forty-six (2546), New Westminster District;

Thence in a Southeasterly direction along the Westerly boundary and the Westerly boundary produced of said Lot Nine (9) to the Easterly boundary of Lot One (1), Block One Hundred Thirty-five (135), Port Mann Townsite, Plan Two Thousand Five Hundred Forty-six (2546), New Westminster District;

Thence South along the Easterly boundary of said Lot One (1) and the Easterly boundary produced to the North boundary of Lot "A" Block One Hundred Thirty-five (135), Port Mann Townsite, Plan Sixteen Thousand Five Hundred Five (16505), New Westminster District;

Thence East along the North boundary of said Lot "A" to the East boundary thereof;

Thence South along the East boundary and the East boundary produced of said Lot "A" to the North boundary of Lot Two (2), Block One Hundred Forty-two (142) Port Mann Townsite, Plan Nine Thousand Six Hundred Seventy-four (9674), New Westminster District;

Thence East along the North boundary of said Lot Two (2) to the East boundary

Thence East along the North boundary of 111th Avenue (Wagner Road) to the West boundary of Lot Seven (7) of Block Twenty-five (25), Section Sixteen (16), Block Five (5) North, Range Two (2) West, Plan One Thousand Eight Hundred Three (1803), New Westminster District;

Thence North along the West boundary and the West boundary produced of said Lot Seven (7) to the South boundary produced of Lot Twelve (12) of Lot "A",

Block Twenty-five (25), Section Sixteen (16), Block Five (5) North, Range Two (2) West, Plan Eighteen Thousand Sixty-seven (18067), New Westminster District;

Thence West along the South boundary produced of said Lot Twelve (12) to the East boundary of said Lot Twelve (12);

Thence North along the East boundary of said Lot Twelve (12) to the South Boundary of 112th Avenue (North Road);

Thence East along the South boundary of 112th Avenue (North Road) to the West boundary of 132nd Street (Roebuck Road);

Thence North along the West boundary of 132nd Street (Roebuck Road) to the North boundary of 114th Avenue (Markham Road);

Thence West along the North boundary of 114th Avenue (Markham Road) to the East boundary of 131st Street (Langley Road);

Thence North along the East boundary of 131st Street (Langley Road) to the South boundary of 114A Avenue (Stanley Road);

Thence East along the South boundary of 114A Avenue (Stanley Road) to the West boundary of 132nd Street (Roebuck Road);

Thence South along the West boundary of 132nd Street (Roebuck Road) to the Westerly production of the North boundary of 114th Avenue (Markham Road);

Thence East along the Westerly production of the North boundary of 114th Avenue (Markham Road) to the point of commencement.

- 2. The Municipal Council shall be and is hereby empowered and authorized to provide, operate, maintain and extend works for the collection and disposal of sewerage in and for "Surrey Sewerage Area No. 1" and to undertake and carry out or cause to be carried out, the construction of the sewerage works shown and described in general plans approved by the Provincial Health Officer, and to do all things necessary in connection therewith and without limiting the generality of the foregoing:
 - (a) To operate, maintain and extend the aforesaid works.
 - (b) To acquire all such real property, easements, rights-of-way, licenses, rights and authorities, as may be requisite or desirable for or in connection with the construction of the works aforesaid;
 - (c) To apply to Central Mortgage and Housing Corporation for a loan pursuant to provisions of Part VIB of the "National Housing Act" to meet part of the construction costs of the sewerage works and as security therefor to pledge part of the debenture issue hereinafter provided for.
- 3. For the purpose and with the object aforesaid and subject to the provisions in that behalf hereinafter contained and set forth there may be borrowed upon the credit of the Corporation the sum of One Million Three Hundred Thousand Dollars (\$1,300,000.00) and debentures may be issued therefor, in sums of not less than One Thousand Dollars (\$1,000.00) each and having coupons attached thereto for the payment of interest at a rate not to exceed six per centum (6%) per annum. The said debentures may be issued in series, each series having a term of not more than twenty-five (25) years.
