

THE CORPORATION OF THE DISTRICT OF SURREY

BY-LAW NO. 11352

A by-law to authorize the purchase of land required for Corporate purposes and to dedicate certain of the said land for use as a public highway.

.....

WHEREAS the land hereinafter described is required for the purpose of the Corporation;

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. The Corporation of the District of Surrey is hereby authorized to purchase from the owner or owners thereof, respectively, the following land, all in the Municipality of Surrey, Province of British Columbia:

A Reference Plan will accompany the following described portions of Sections Nineteen (19) and Thirty (30), Township Two (2), New Westminster District, shown outlined in heavy black line, duly signed by the Mayor and Clerk, prepared by Peter M. Mueller, B.C.L.S. on April 10, 1992, and described as follows:

Portions lying in Section Nineteen (19):

(a) That portion of Lot "A", Plan Twenty Thousand Eight Hundred Seventy-Five (20875), containing Twenty (20) square metres;

(Portion of 12414 - 80 Avenue)

at or for the sum of Three Thousand Two Hundred Fifty-Five Dollars (\$3,255.00), plus tax adjustments and conveyancing costs;

(b) That portion of Lot Three (3), Plan Thirteen Thousand Eight Hundred Eighty-Nine (13889), containing Twenty (20) square metres;

(Portion of 12384 - 80 Avenue)

at or for the sum of One Thousand Three Hundred Sixty-Five Dollars (\$1,365.00), plus tax adjustments and conveyancing costs;

Portions lying in Section Thirty (30):

(c) That portion of Lot Thirty-Two (32), Plan Thirty-One Thousand One Hundred Eighteen (31118), containing Nine (9) square metres;

(Portion of 8017 - 124 Street)

at or for the sum of Five Hundred Fifty-Eight Dollars (\$558.00), plus tax adjustment and conveyancing costs;

(d) That portion of Parcel "A", Reference Plan Seventy-Two Thousand Four Hundred Eighty-Nine (72489), containing Sixty-Two (62) square metres;

(Portion of 12457 - 80 Avenue)

at or for the sum of Two Thousand Six Hundred Eighty Dollars (\$2,680.00), plus tax adjustment and conveyancing costs.

2. Upon receipt of good and valid conveyance of said land in favour of the Corporation, the Mayor and Treasurer are hereby authorized to pay to the owner or owners thereof out of Corporate funds the purchase price as hereinbefore mentioned.
3. Upon conveyance of the land described in Section One (l) hereof, to the Corporation, the same shall be and it is hereby declared to be set aside and used by The Corporation of the District of Surrey as a public highway only.
4. A reference plan will accompany this By-law for registration purposes, outlining the above property in black, and duly signed by the Mayor and Clerk.
5. This By-law may be cited for all purposes as "Land Purchase And Highway Dedication By-law, 1992, No. 11352."

PASSED THREE READINGS by the Municipal Council on the 15th day of June, 1992.
