AND WHEREAS it is now deemed advisable to amend the agreement attached to and forming part of said By-law 11546;

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, hereby ENACTS AS FOLLOWS:

1. The Surrey Sailing Club Land Leasing By-law, 1992, No. <u>11546</u>" is hereby amended in Section 1 by deleting the legal description of the land and inserting the following description of the land in its place:

"ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia and being a portion of Lot Two Hundred Thirty-One (231) and Lot Four Hundred Ninety-One (491), Group Two (2), New Westminster District as shown outlined in bold back on the plan attached to Schedule 1 to this By-law."

(3140 McBride Avenue)

2. The Mayor and Clerk are hereby authorized to execute an agreement on behalf of The Corporation of the District of Surrey, in the form attached hereto and forming Schedule "1" to this By-law with THE SURREY SAILING CLUB to provide certain amendments to the agreement which is Schedule "A" attached to and forming part of The Surrey Sailing Club Land Leasing By-law, 1992, No. <u>11546</u>."

3. This By-law shall be cited for all purposes as "The Surrey Sailing Club Land Leasing By-law, 1992, No. <u>11546</u>, Amendment By-law, 1993, No. 11757."
