A by-law to dispose of portions of a public highway in exchange for adjoining lands necessary for a public highway.

(INC. #334040), ALL AND SINGULAR those certain parcels or tracts of land and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia:

All that portion of Sections 21 and 28, Township 2, New Westminster District, dedicated as Road on Plan 4217, shown hatched and outlined bold on the copy of the Reference Plan hereunto attached, said Reference Plan prepared by R.H. Janzen, B.C.L.S. and signed by him on the 15th day of March, 1993, the said portion containing 0.489 hectares more or less.

2. For the purpose of acquiring adjacent lands for a public highway, The Mayor and Clerk are authorized to accept from DAWSON LANDS 1987 LTD.
