THE CORPORATION OF THE DISTRICT OF SURREY

BY-LAW NO. 11814

A by-law to dispose of portions of a public highway in exchange for adjoining lands necessary for a public highway.

.....

WHEREAS pursuant to Section 574(1) of the "Municipal Act", being Chapter 290, R.S.B.C., the Council may by bylaw dispose of a portion of a highway in exchange for land necessary for the purpose of improving, widening, straightening, relocating or diverting a highway;

WHEREAS The Corporation of The District of Surrey is the owner of the land described in Section 2 of this By-law and has agreed with The Corporation of the District of Surrey to make the exchange hereinafter provided for;

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

l. Upon receiving from the said The Corporation of the District of Surrey the conveyance or other assurance mentioned in Section 2 hereof, the Mayor and the Clerk of The Corporation of The District of Surrey are hereby authorized, in exchange therefore, to execute and deliver on behalf of The Corporation such conveyance or other assurance as may be necessary for vesting in The Corporation of The District of Surrey, ALL AND SINGULAR those certain parcels or tracts of land and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia:

Those portions of road lying in Section Eighteen (18), Township Two (2), New Westminster District, dedicated by Plan One-Thousand One-Hundred Fifty-Five (1155) shown hatched on Reference Plan attached hereto, duly signed by the Mayor and Clerk, prepared by Alan J. Zacharias, B.C.L.S. on the 31st day of March, 1993, the said portions may be described as follows:

That portion containing Zero and One-Hundred Ninety One-Thousandths (0.190) hectares;

That portion containing Zero and One-Hundred Sixty-Nine One-Thousandths (0.169) hectares.

(Portion of 123 Street

between 68A and 70 Avenues)

2. For the purpose of acquiring adjacent lands for a public highway, The Mayor and Clerk are authorized to accept from The Corporation of The District of Surrey, in exchange for the land mentioned in Clause One (l) hereof, the sum of One Dollar (\$1.00), together with such conveyance or other assurance as may be necessary to vest in the Crown as

a public highway, ALL AND SINGULAR those certain parcels or tracts of lands and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia:

That portion of Lot "B", Section Eighteen (18), Township Two (2), New Westminster District, Plan Eighty-Five Thousand Three-Hundred Fifty-Nine (85359), shown outlined in heavy black line on Reference Plan attached hereto, duly signed by the Mayor and Clerk, prepared by Alan J. Zacharias, B.C.L.S. on the 31st day of

March, 1993, and containing One-Hundred Forty-Two (142) square metres.

(Portion of 6889 - 123 Street)

3. This By-law may be cited for all purposes as "123 Street Road Exchange By-law, 1993, No. 11814."

PASSED THREE READINGS by the Municipal Council on the 3rd day of May, 1993.

ADVERTISED in the Surrey-North Delta Now newspaper on the 15th day of May, 1993 and on the 22nd day of May, 1993.
