<u>BY-LAW NO. 11815</u>

A by-law to dispose of portions of a public highway in exchange for adjoining lands necessary for a public highway.

WHEREAS pursuant to Section 574(1) of the "Municipal Act", being Chapter 290, R.S.B.C., the Council may by bylaw dispose of a portion of a highway in exchange for land necessary for the purpose of improving, widening, straightening, relocating or diverting a highway;

WHEREAS GARY KYALL DAVIDSON and PATRICIA ANN DAVIDSON are the owners of the land described in Section 2 of this By-law and have agreed with The Corporation of the District of Surrey to make the exchange hereinafter provided for;

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Upon receiving from the said GARY KYALL DAVIDSON and PATRICIA ANN DAVIDSON the conveyance or other assurance mentioned in Section 2 hereof, the Mayor and the Clerk of The Corporation of the District of Surrey are hereby authorized, in exchange therefore, to execute and deliver on behalf of The Corporation such conveyance or other assurance as may be necessary for vesting in GARY KYALL DAVIDSON and PATRICIA ANN DAVIDSON, ALL AND SINGULAR those certain parcels or tracts of land and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia.

That portion of road in Section 18, Township 2, New Westminster District, dedicated by Plan 21061, shown hatched on Reference Plan attached hereto duly signed by the Mayor and Clerk, prepared by John Onderwater, B.C.L.S. on March 31, 1993, and containing 499 square metres.

(Part of 70 Avenue east of 123 Street)

2. For the purpose of acquiring adjacent lands for a public highway, The Mayor and Clerk are authorized to accept from GARY KYALL DAVIDSON and PATRICIA ANN DAVIDSON, in exchange for the land mentioned in Clause One (l) hereof, the sum of Five Thousand Seven Hundred Forty-Two Dollars (\$5,742.00), together with such conveyance or other assurance as may be necessary to vest in the Crown as a public highway, ALL AND SINGULAR those certain parcels or tracts of lands and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia:

All that portion of Lot 3, Section 18, Township 2, New Westminster District, Plan 21061, shown outlined in heavy black line on Reference Plan attached hereto, duly signed by the Mayor and Clerk, prepared by John Onderwater, B.C.L.S. on March 31, 1993, and containing 1.45 square metres.

(Part of 6988 - 123 Street)

3. This By-law may be cited for all purposes as "Portion 0f 70 Avenue Road Exchange By-law, 1993, No. 11815."
