BY-LAW NO. 11854

A by-law to dispose of portions of a public highway in exchange for adjoining lands necessary for a public highway.

WHEREAS pursuant to Section 574(1) of the "Municipal Act", being Chapter 290, R.S.B.C., the Council may by bylaw dispose of a portion of a highway in exchange for land necessary for the purpose of improving, widening, straightening, relocating or diverting a highway;

WHEREAS HENRY DOUGLAS BOSE and DOREEN GRACE BOSE are the owners of the land described in Section 2 of this By-law and have agreed with The Corporation of the District of Surrey to make the exchange hereinafter provided for;

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Upon receiving from the said HENRY DOUGLAS BOSE and DOREEN GRACE BOSE the conveyance or other assurance mentioned in Section 2 hereof, the Mayor and the Clerk of The Corporation of the District of Surrey are hereby authorized, in exchange therefore, to execute and deliver on behalf of The Corporation such conveyance or other assurance as may be necessary for vesting in HENRY DOUGLAS BOSE and DOREEN GRACE BOSE, ALL AND SINGULAR those certain parcels or tracts of land and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia:

That portion of road lying in Section Eleven (11), Township Two (2), New Westminster District, dedicated by Plan Twenty-Seven Thousand Three Hundred Seventy-Five (27375), shown hatched on Reference Plan attached hereto, duly signed by the Mayor and Clerk, prepared by Peter M. Mueller, BCLS, on May 10, 1993 and containing One and Twelve One-Hundredths (1.12) Hectares.

(Portion of 61 Avenue east of 156 Street)

2. For the purpose of acquiring adjacent lands for a public highway, The Mayor and Clerk are authorized to accept from HENRY DOUGLAS BOSE and DOREEN GRACE BOSE, in exchange for the land mentioned in Clause One (l) hereof, the sum of One Dollar (\$1.00), together with such conveyance or other assurance as may be necessary to vest in the Crown as a public highway, ALL AND SINGULAR those certain parcels or tracts of lands and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia:

That portion of Lot Twenty (20), Section Eleven (11), Township (2), New Westminster District, Plan Twenty-Seven Thousand Three Hundred Seventy-Three (27373), shown outlined in heavy black line on Reference Plan attached hereto, duly signed by the Mayor and Clerk, prepared by Peter M. Mueller, BCLS, on May 10, 1993 and containing Zero and Five Hundred Ninety-Nine One-Thousandths (0.599) Hectares.

(Portion of 15632 - 64 Avenue)
3. This By-law may be cited for all purposes as "Portion of 64 Avenue/156 Street Road Exchange By-law, 1993, No. 11854."
