A by-law to authorize the purchase of
lands required for Corporate purposes.

All that portion of Lot "B" Except: Parcel "F" (Reference Plan 30036), District Lot 12, Group 2, New Westminster District, Plan 4959, included within the new Lot 1, Plan LMP9871;

(Portion of 10141 Grace Road)

All that portion of District Lot 13, Group 2, lying between the Statutory Right of Way of the Vancouver, Victoria and Eastern Railway and Navigation Company shown on Plan with fee deposited 17351F and part shown red on Plan with Bylaw Filed 17500, New Westminster District, included within the new Lot 1, Plan LMP9871;

(Portion of 10079 Grace Road)

All that portion of Parcel "C" (N9819E), District Lot 11, Group 2, New Westminster District, included within the new Lot 2, Plan LMP9871; and

(Portion of 10239 Grace Road)

All that portion of Lot "C" Except: Parcel "G" (Reference Plan 30036), District Lot 12, Group 2, New Westminster District, Plan 4959, included within the new Lot 2, Plan LMP9871.

(Portion of 10175 Grace Road)

at or for the sum of One Dollar (\$1.00) in each instance, plus tax adjustment and conveyancing costs.

2. Upon receipt of good and valid conveyance of said lands in favour of the Corporation, the Mayor and Treasurer

are hereby authorized to pay to the owner or owners thereof out of Corporate funds the purchase price as hereinbefore mentioned.
3. Upon conveyance of the lands described in Section One (l) hereof to the Corporation, the same shall be and it is hereby declared to be set aside and used for Corporate purposes.
