

THE CORPORATION OF THE DISTRICT OF SURREY

BY-LAW NO. 11897

A by-law to dispose of portions of a public highway in exchange for adjoining lands necessary for a public highway.

.....

WHEREAS pursuant to Section 574(1) of the "Municipal Act", being Chapter 290, R.S.B.C., the Council may by by-law dispose of a portion of a highway in exchange for land necessary for the purpose of improving, widening, straightening, relocating or diverting a highway;

AND WHEREAS the Registered Owner of the land described in Section 2 of this By-law has agreed with The Corporation of the District of Surrey to make the exchange hereinafter provided for;

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Upon receiving from the said Registered Owner the conveyance or other assurance mentioned in Section 2 hereof, the Mayor and the Clerk of The Corporation of the District of Surrey are hereby authorized, in exchange therefore, to execute and deliver on behalf of The Corporation such conveyance or other assurance as may be necessary for vesting in the said Registered Owner, ALL AND SINGULAR those certain parcels or tracts of land and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia.

All that portion of road in Section 15, Township 8, New Westminster District, dedicated by Plan 3974, shown hatched on the Reference Plan, a copy of which is attached hereto, duly signed by the Mayor and Clerk, and was prepared by Henry A.R.P. Aldridge, B.C.L.S. on June 10, 1993, and containing 1072 square metres.

(Portion of 64 Avenue east of 192 Street)

All that portion of road in Section 10, Township 8, New Westminster District, dedicated by Reference Plan 67872, shown hatched on a Reference Plan, a copy of which is attached hereto, duly signed by the Mayor and Clerk, and was prepared by Henry A.R.P. Aldridge, B.C.L.S. on June 10, 1993, and containing 163 square metres.

(Portion of 64 Avenue east of 192 Street)

All that portion of constructed road in Section 10, Township 8, New Westminster District, dedicated by B.C. Gazette Notice May 22nd, 1875, shown hatched on the Reference Plan, a copy of which is attached hereto, duly signed by the Mayor and Clerk, and was prepared by Henry A.R.P. Aldridge, B.C.L.S. on June 10, 1993, and containing 1364 square metres.

(Portion of 64 Avenue east of 192 Street)

2. For the purpose of acquiring adjacent lands for a public highway, The Mayor and Clerk are authorized to accept from the said Registered Owner, in exchange for the land mentioned in Clause One (1) hereof, the sum of Thirty Six Thousand Five Hundred Fifty-Nine Dollars (\$36,559.00), together with such conveyance or other assurance as may be necessary to vest in the Crown as a public highway, ALL AND SINGULAR those certain parcels or tracts of lands and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia:

All that portion of Lot 1 Except: Part on Statutory Right of Way Plan 75574, Section 10, Township 8, New Westminster District, Plan 9440, shown within the heavy outline on the Reference Plan, a copy of which is attached hereto, duly signed by the Mayor and Clerk, and was prepared by Henry A.R.P. Aldridge, B.C.L.S. on June 10, 1993, and containing 20.10 square metres.

(Portion of 19209 Fraser Highway)

3. This By-law may be cited for all purposes as "Portion Of 64 Avenue/192 Street Road Exchange By-law, 1993, No. 11897."

PASSED FIRST AND SECOND READINGS by the Municipal Council on the 21st day of June, 1993.

ADVERTISED in the Surrey-North Delta Now newspaper on the 3rd day of June, 1993 and on the 10th day of June, 1993.

READ A THIRD TIME on the 25th day of July, 1994.
