11934 - Portion of 80 Avenue/144 Street Road Exchange By-law, 1993, No. 11934

THE CORPORATION OF THE DISTRICT OF SURREY

BY-LAW NO. 11934

A by-law to dispose of portions of a public highway in exchange for adjoining lands necessary for a public highway.

.....

WHEREAS pursuant to Section 574(1) of the "Municipal Act", being Chapter 290, R.S.B.C., the Council may by bylaw dispose of a portion of a highway in exchange for land necessary for the purpose of improving, widening, straightening, relocating or diverting a highway;

WHEREAS HERMAN WILLIAM ALBERT SCHUURMAN and MARIA CHRISTINA SCHUURMAN are the owners of the land described in Section 2 of this By-law and have agreed with The Corporation of the District of Surrey to make the exchange hereinafter provided for;

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

I. Upon receiving from the said HERMAN WILLIAM ALBERT SCHUURMAN and MARIA CHRISTINA SCHUURMAN the conveyance or other assurance mentioned in Section 2 hereof, the Mayor and the Clerk of The Corporation of the District of Surrey are hereby authorized, in exchange therefore, to execute and deliver on behalf of The Corporation such conveyance or other assurance as may be necessary for vesting in HERMAN WILLIAM ALBERT SCHUURMAN and MARIA CHRISTINA SCHUURMAN, ALL AND SINGULAR those certain parcels or tracts of land and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia.

That portion of Section 27, Township 2, New Westminster District, shown dedicated as road on Plan 5946, herein referred to as Parcel C, shown hatched and outlined in black on copy of the Reference Plan hereunto attached, said Reference Plan prepared by J.G. Cameron, B.C.L.S. and signed by him on the 2nd day of June, 1993, the said portion containing 959 square metres, more or less.

(Portion of 80 Avenue east of 144 Street)

That portion of Section 22, Township 2, New Westminster District, shown dedicated as road on Plan 6535, herein referred to as Parcel D, shown hatched and outlined in black on copy of the Reference Plan hereunto attached, said Reference Plan prepared by J.G. Cameron, B.C.L.S. and signed by him on the 2nd day of June, 1993, the said portion containing 983 square metres, more or less.

(Portion of 80 Avenue east of 144 Street)

That portion of Section 22, Township 2, New Westminster District, shown dedicated as Road on Plan LMP11, herein referred to as Parcel E, shown hatched and outlined in black on copy of the Reference Plan hereunto attached,

said Reference Plan prepared by J.G. Cameron, B.C.L.S. and signed by him on the 2nd day of June, 1993, the said portion containing 187 square metres, more or less.

(Portion of 80 Avenue east of 144 Street)

2. For the purpose of acquiring adjacent lands for a public highway, The Mayor and Clerk are authorized to accept from HERMAN WILLIAM ALBERT SCHUURMAN and MARIA CHRISTINA SCHUURMAN, in exchange for the land mentioned in Clause One (l) hereof, the sum of One Dollar (\$1.00), together with such conveyance or other assurance as may be necessary to vest in the Crown as a public highway, ALL AND SINGULAR those certain parcels or tracts of lands and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia:

That portion of Lot B, Section 27, Township 2, New Westminster District, Plan 15090, shown outlined in black, herein referred to as Parcel A, on copy of the Reference Plan hereunto attached, said Reference Plan prepared by J.G. Cameron, B.C.L.S. and signed by him on the 2nd day of June, 1993, the said portion containing 262 square metres, more or less.

(Portion of 8014 - 144 Street)

3. This By-law may be cited for all purposes as "Portion of 80 Avenue/144 Street Road Exchange By-law, 1993, No. 11934"
