## BY-LAW NO. 11964

A by-law to dispose of portions of a public highway in exchange for adjoining lands necessary for a public highway.

AND WHEREAS REDEKOP PROPERTIES (SURREY PLACE) INC. #411619 is the owners of the land described in Section 2 of this By-law and has agreed with The Corporation of the District of Surrey to make the exchange hereinafter provided for;

1. Upon receiving from the said REDEKOP PROPERTIES (SURREY PLACE) INC. #411619 the conveyance or other assurance mentioned in Section 2 hereof, the Mayor and the Clerk of The Corporation of the District of Surrey are hereby authorized, in exchange therefore, to execute and deliver on behalf of The Corporation such conveyance or other assurance as may be necessary for vesting in REDEKOP PROPERTIES (SURREY PLACE) INC. #411619, ALL AND SINGULAR those certain parcels or tracts of land and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia:

That portion of Section 35, Block 5 North, Range 2 West, New Westminster District, shown dedicated as Lane on Plan 22251, shown hatched and referred to as Pcl. B on copy of Reference Plan hereunto attached, said Reference Plan prepared by Eric N. Peterson, B.C.L.S., and signed by him on the 8th day of July, 1993, the said portion containing 186 square metres more or less

(Unopened lane between Laurel Drive and the Fraser Highway, west of 140 Street)

2. 3. This By-law may be cited for all purposes as "Portion of Lane/Laurel Drive Road Exchange By-law, 1993, No. 11964."
