

CITY OF SURREY

BY-LAW NO. 12077

A by-law to dispose of portions of a public highway in exchange for adjoining lands necessary for a public highway.

.....

WHEREAS pursuant to Section 574(1) of the "Municipal Act", being Chapter 290, R.S.B.C., the Council may by by-law dispose of a portion of a highway in exchange for land necessary for the purpose of improving, widening, straightening, relocating or diverting a highway;

AND WHEREAS the Registered Owner of the land described in Section 2 of this By-law and has agreed with the City of Surrey to make the exchange hereinafter provided for;

NOW, THEREFORE, the Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Upon receiving from the said Registered Owner, the conveyance or other assurance mentioned in Section 2 hereof, the Mayor and the Clerk of the City of Surrey are hereby authorized, in exchange therefore, to execute and deliver on behalf of The City such conveyance or other assurance as may be necessary for vesting in the said Registered Owner, ALL AND SINGULAR those certain parcels or tracts of land and premises situate, lying and being in the City of Surrey, in the Province of British Columbia:

All that portion of Road lying in District Lots 52 and 231, Group 2, New Westminster District, dedicated by Plan 5014 and shown outlined in heavy black line on Sketch 'B' attached hereto prepared by Peter M. Mueller, B.C.L.S. on October 25, 1993 and containing 142.9 square metres.

(Portion of Wickson Road)

2. For the purpose of acquiring adjacent lands for a public highway, the Mayor and Clerk are authorized to accept from the said Registered Owner, in exchange for the land mentioned in Clause One (1) hereof, the sum of One Dollar (\$1.00), together with such conveyance or other assurance as may be necessary to vest in the Crown as a public highway, ALL AND SINGULAR those certain parcels or tracts of lands and premises situate, lying and being in the City of Surrey, in the Province of British Columbia:

All that portion of Lot 'A', District Lots 52 and 231, Group 2, New Westminster District, Plan LMP9654 shown outlined in heavy black line on Sketch 'B' attached hereto prepared by Peter M. Mueller, B.C.L.S. on October 25, 1993 and containing 149.8 square metres.

(Portion of 12215 Wickson Road)

3. This By-law may be cited for all purposes as "Wickson Road Road Exchange By-law, 1993, No. 12077."
