CITY OF SURREY

BY-LAW NO. 12228

A by-law to dispose of portions of a public highway in exchange for adjoining lands necessary for a public highway.

WHEREAS pursuant to Section 574(1) of the "Municipal Act", being Chapter 290, R.S.B.C., the Council may by by-law dispose of a portion of a highway in exchange for land necessary for the purpose of improving, widening, straightening, relocating or diverting a highway;

AND WHEREAS the Registered Owner of the land described in Section 2 of this By-law has agreed with the City of Surrey to make the exchange hereinafter provided for;

NOW, THEREFORE, the Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Upon receiving from the said Registered Owner, the conveyance or other assurance mentioned in Section 2 hereof, the Mayor and the Clerk of the City of Surrey are hereby authorized, in exchange therefore, to execute and deliver on behalf of the City such conveyance or other assurance as may be necessary for vesting in the said Registered Owner, ALL AND SINGULAR those certain parcels or tracts of land and premises situate, lying and being in the City of Surrey, in the Province of British Columbia:

A Reference Plan will accompany the following described Portions shown hatched duly signed by the Mayor and Clerk prepared by Peter M. Mueller, B.C.L.S. on December 28, 1993, and described as follows:

That Portion of Lane lying in Block Seven (7), Section Twenty-Two (22), Block Five (5) North, Range One (1) West, New Westminster District, dedicated by Plan One Thousand Eight Hundred Thirty-Two (1832), and containing Three Hundred Seventy-One (371) Square Metres;

(Portion of Lane North of 107 Avenue)

That Portion of Road lying between Blocks Seven (7) and Ten (10), Section Twenty-Two (22), Block Five (5) North, Range One (1) West, New Westminster District, dedicated by Plan One Thousand Eight Hundred Thirty-Two (1832), and containing Zero and One Hundred Ninety-Five One-Thousandths (0.195) Hectares; and

(Portion of 107 Avenue)

That Portion of Lane and Road lying in Block Ten (10), Section Twenty-Two (22), Block Five (5) North, Range One (1) West, New Westminster District, dedicated by Plan One Thousand Eight Hundred Thirty-Two (1832), and containing Seven Hundred Eighty-Two (782) Square Metres.

(Portion of Road and Lane South of 107 Avenue)

2. For the purpose of acquiring adjacent lands for a public highway, the Mayor and Clerk are authorized to accept from the said Registered Owner, in exchange for the land mentioned in Section 1 hereof, the sum of One Dollar (\$1.00), together with such conveyance or other assurance as may be necessary to vest in the Crown as a public highway, ALL AND SINGULAR those certain parcels or tracts of lands and premises situate, lying and being in the City of Surrey, in the Province of British Columbia:

A Reference Plan will accompany the following described portions shown outlined in heavy black line duly signed by the Mayor and Clerk prepared by Peter M. Mueller, B.C.L.S. on December 28, 1993 and described as follows:

That Portion of Lot Fourteen (14), Block Seven (7), Section Twenty-Two (22), Block Five (5) North, Range One (1) West, New Westminster District, Plan One Thousand Eight Hundred Thirty-Two (1832), and containing Seventeen (17) Square Metres; and

(Portion of 15753 - 107 Avenue)

That Portion of Lot Fifteen (15), Block Seven (7), Section Twenty-Two (22), Block Five (5) North, Range One (1) West, New Westminster District, Plan One Thousand Eight Hundred Thirty-Two (1832), and containing One Hundred Twenty-Five (125) Square Metres.

(Portion of 15743 - 107 Avenue)

3. This By-law may be cited for all purposes as "107 Avenue Road Exchange By-law, 1994, No. 12228."

PASSED THREE READINGS on the 21st day of March, 1994.




