CITY OF SURREY

BY-LAW NO. 12270

A by-law to dispose of portions of a public highway in exchange for adjoining lands necessary for a public highway.

WHEREAS pursuant to Section 574(1) of the "Municipal Act", being Chapter 290, R.S.B.C., the Council may by by-law dispose of a portion of a highway in exchange for land necessary for the purpose of improving, widening, straightening, relocating or diverting a highway;

AND WHEREAS the Registered Owner of the land described in Section 2 of this By-law has agreed with the City of Surrey to make the exchange hereinafter provided for;

NOW, THEREFORE, the Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Upon receiving from the said Registered Owner, the conveyance or other assurance mentioned in Section 2 hereof, the Mayor and the Clerk of the City of Surrey are hereby authorized, in exchange therefore, to execute and deliver on behalf of the City such conveyance or other assurance as may be necessary for vesting in the said Registered Owner, ALL AND SINGULAR those certain parcels or tracts of land and premises situate, lying and being in the City of Surrey, in the Province of British Columbia:

That portion of Lane dedicated on Plan 24234 of Section 20, Township 2, New Westminster District, shown within the bold outline and hatched on a Reference Plan prepared by G.A. Hol, B.C.L.S., dated the 16th day of March, 1994, having an area of 235 square metres, a copy of said Reference Plan attached hereto.

(Portion of lane between 79A Avenue and 80 Avenue, west of the King George Highway)

2. For the purpose of acquiring adjacent lands for a public highway, the Mayor and Clerk are authorized to accept from the said Registered Owner, in exchange for the land mentioned in Section 1 hereof, the sum of Thirteen Thousand Seven Hundred Dollars (\$13,700.00), together with such conveyance or other assurance as may be necessary to vest in the Crown as a public highway, ALL AND SINGULAR those certain parcels or tracts of lands and premises situate, lying and being in the City of Surrey, in the Province of British Columbia:

That portion of Lot 1, Except: Part within heavy outline taken by Highway Statutory Right of Way Plan 63551, Section 20, Township 2, New Westminster District, Plan 13102, shown within the bold outline on a Reference Plan prepared by G.A. Hol, B.C.L.S. dated the 16th day of March, 1994, having an area of 159 square metres, a copy of said Reference Plan attached hereto.

(Portion of 13568 - 80 Avenue)

3. This By-law may be cited for all purposes as "Portion of 80 Avenue Road Exchange By-law, 1994, No. 12270."
