Upon receiving from the said Registered Owner, the conveyance or other assurance mentioned in Section 2 hereof, the Mayor and the Clerk of the City of Surrey are hereby authorized, in exchange therefore, to execute and deliver on behalf of the City such conveyance or other assurance as may be necessary for vesting in the said Registered Owner, ALL AND SINGULAR those certain parcels or tracts of land and premises situate, lying and being in the City of Surrey, in the Province of British Columbia:

All that portion of road dedicated by Plan 14957, lying in Section 25, Township 2, New Westminster District, shown hatched within the heavy black line on Reference Plan attached hereto, duly signed by the Mayor and Clerk, prepared by R.K. Riecken, B.C.L.S., on the Fifteenth Day of May 1995, and containing Three Hundred and Fifty-Nine (359) Square Metres; and

(Portion of 163A Street)

That portion of lane dedicated by Plan 15783, lying in Section 25, Township 2, New Westminster District, shown hatched within the heavy black line on Reference Plan attached hereto, duly signed by the Mayor and Clerk, prepared by R.K. Riecken, B.C.L.S., on the Fifteenth Day of May 1995, and containing One Hundred and Eleven (111) Square Metres.
