BY-LAW NO. 12680

A by-law to remove the park reservation from the Fleetwood Sports Complex lands.

WHEREAS, pursuant to the provisions of the "Land Purchase By-law, 1987, No. 9245," the following lands:

The West Portion of Lot Two (2) of the South East Quarter (SE 1/4) of Section Twenty-Five (25), Township Two (2), Plan Three Thousand Four Hundred Forty-Eight (3448) being all that portion lying west of a straight line bisecting the north and south boundaries thereof New Westminster District;

(16479 Fraser Highway)

Parcel "A" (J18156E) of Lot Two (2) of the South East Quarter (SE 1/4) of Section Twenty-Five (25), Township Two (2), Plan Three Thousand Four Hundred Forty-Eight (3448) New Westminster District;

(16509 Fraser Highway)

Lot Three (3) of the South East Quarter (SE 1/4) of Section Twenty-Five (25), Township Two (2), Plan Three Thousand Four Hundred Forty-Eight (3448) New Westminster District; and

(16529 Fraser Highway)

Lot Four (4) of the South East Quarter (SE 1/4) of Section Twenty-Five (25), Township Two (2), Plan Three Thousand Four Hundred Forty-Eight (3448) New Westminster District.

(16579 Fraser Highway)

were purchased and set aside for park purposes;

AND WHEREAS, pursuant to the provisions of Section 532 of the "Municipal Act", the City Council may, by by-law, remove any reservation placed upon land pursuant to this section. A by-law for such removal requires the approval of the Minister of Municipal Affairs; AND WHEREAS the lands are now known as West Half Lot 2, Section 25, Township 2, New Westminster District, Plan 3448 located at 16479 Fraser Highway; Parcel "A" (J18156E) Lot 2, Section 25, Township 2, New Westminster District, Plan 3448 located at 16509 Fraser Highway; and Lot B (BE72883) Section 25, Township 2, New Westminster District, Plan 3448 located at 16529 Fraser Highway;

AND WHEREAS it is deemed expedient to remove the park reservation from a portion of the lands known and described as West Half Lot 2, Section 25, Township 2, New Westminster District, Plan 3448 located at 16479 Fraser Highway; Parcel "A" (J18156E) Lot 2, Section 25, Township 2, New Westminster District, Plan 3448 located at 16509 Fraser Highway; and Lot B (BE72883) Section 25, Township 2, New Westminster District, Plan 3448 located at 16529 Fraser Highway, in order to permit the development of a multi-faceted sports complex;

NOW, THEREFORE, the City Council, in open meeting assembled, enacts as follows:

1. The City Council hereby removes the reservation for park purposes imposed on:

West Half Lot 2, Section 25, Township 2, New Westminster District, Plan 3448, except the northerly 129.24 metres;

(Portion of 16479 Fraser Highway)

Parcel "A" (J18156E) Lot 2, Section 25, Township 2, New Westminster District, Plan 3448, except the northerly 129.24 metres; and

(Portion of 16509 Fraser Highway)

Lot B (BE72883) Section 25, Township 2, New Westminster District, Plan 3448, except the northerly 129.24 metres.

(Portion of 16529 Fraser Highway)

(Above area shown shaded as Block 2 on Schedule "A" attached hereto to this by-law)

which said reservation was made pursuant to the provisions of "Land Purchase By-law, 1987, No. 9245."

 This By-law may be cited for all purposes as "Fleetwood Sports Complex Park Reservation Cancellation By-law, 1995, No. 12680." PASSED FIRST READING on the 5th day of September, 1995.
