BY-LAW NO. 12926

A by-law to amend “Sunnyside Acres Urban Forest Park and Park Dedication By-law, 1988, No. 9800”.

.....

WHEREAS the Sunnyside Acres Urban Forest Park and Sunnyside Acres Park were dedicated by the Council of the City of Surrey as urban forest and park in 1988, by way of By-law 9800, pursuant to Section 533 of the **Municipal Act** Chapter 290, R.S.B.C. 1979 as amended (the “**Act**”);

AND WHEREAS Council of the City of Surrey, pursuant to Section 533 of the **Act**, deems it expedient to amend By-law 9800 and remove a portion of lands, shown as Lot A on Appendix “I” attached hereto, from Sunnyside Acres Park dedicated as park and dedicate the same as urban forest park, to be included as part of Sunnyside Acres Urban Forest Park;

NOW, THEREFORE, the City Council of the City of Surrey in open meeting assembled  
HEREBY ENACTS AS FOLLOWS:

1. “Sunnyside Acres Urban Forest Park and Park Dedication By-law, 1988, No. 9800” is hereby amended as follows:

(a) Section 2 is hereby amended by deleting the legal description and substituting the following legal description:

Lot 1 Section 22 Township 1 New Westminster District Plan 83184

Lot 2 Sections 15 and 16 Township 1 New Westminster District Plan 83184

Lot A Section 15 Township 1 New Westminster District Plan LMP \_\_\_\_\_

As outlined in darker outline on Schedule “A” to this By-law and shown as Urban Forest Park

- (b) Section 3 is hereby amended by deleting the legal description and substituting the following legal description:

Lot 3 Section 15 Township 1 New Westminster District Plan 83184 SAVE AND EXCEPT Lot A Section 15 Township 1 New Westminster District Plan LMP \_\_\_\_\_

Lot 4 Section 15 Township 1 New Westminster District Plan 83184

As outlined in lighter outline on Schedule "A" to this By-law and shown as Park.

2. Schedule "A" to By-law 9800 is hereby deleted and a new Schedule "A", as attached hereto, is substituted therefore.
3. The Mayor and Clerk are hereby authorized and empowered to sign any documents required by and to do any acts necessary and incidental to the carrying out of this By-law.
4. This By-law may be cited as "Sunnyside Acres Urban Forest Park and Park Dedication By-law, 1988, No. 9800, Amendment By-law, 1996, No. 12926."

PASSED THREE READINGS on the 23rd day of September, 1996.

RECEIVED the assent of the electors on the 16th day of November, 1996.

RECONSIDERED AND FINALLY ADOPTED, signed by the Mayor and Clerk, and sealed with the Corporate Seal on the 25th day of November, 1996.
