# CITY OF SURREY

### BY-LAW NO. 12991

A by-law to dispose of portions of a public highway in exchange for adjoining lands necessary for a public highway.

WHEREAS pursuant to Section 574(1) of the "Municipal Act", being Chapter 290, R.S.B.C., the Council may by by-law dispose of a portion of a highway in exchange for land necessary for the purpose of improving, widening, straightening, relocating or diverting a highway;

AND WHEREAS the Registered Owner of the land described in Section 2 of this By-law has agreed with the City of Surrey to make the exchange hereinafter provided for;

NOW, THEREFORE, the Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

 Upon receiving from the said Registered Owner, the conveyance or other assurance mentioned in Section 2 hereof, the Mayor and the Clerk of the City of Surrey are hereby authorized, in exchange therefore, to execute and deliver on behalf of the City such conveyance or other assurance as may be necessary for vesting in the said Registered Owner, ALL AND SINGULAR those certain parcels or tracts of land and premises situate, lying and being in the City of Surrey, in the Province of British Columbia:

Those Portions of Road of Section Twenty-Three (23), Township One (1), New Westminster District dedicated on Plan 11831 as shown hatched on a Reference Plan attached hereto, duly signed by the Mayor and Clerk, prepared by D. J. Dyck, British Columbia Land Surveyor on the Eighth (8th) day of October, 1996 and comprised of two (2) portions containing Six Hundred and Eighty-Three (683) Square Metres and Four Hundred and Fifty-Seven (457) Square Metres.

(Portion of Lane West of 155 Street) (Portion of 155 Street) 2. For the purpose of acquiring adjacent lands for a public highway, the Mayor and Clerk are authorized to accept from the said Registered Owner, in exchange for the land mentioned in Section 1 hereof, the sum of Thirty-Five Thousand Seven Hundred Thirty-Eight Dollars (\$35,738.00), together with such conveyance or other assurance as may be necessary to vest in the Crown as a public highway, ALL AND SINGULAR those certain parcels or tracts of lands and premises situate, lying and being in the City of Surrey, in the Province of British Columbia:

All that Part of Lot One (1), Section Twenty-One (21), Township Two (2), New Westminster District, Plan LMP 17431 included within the heavy outline on a Reference Plan attached hereto, duly signed by the Mayor and Clerk, prepared by D. J. Dyck, British Columbia Land Surveyor on the Eighth (8th) day of October 1996.

The herein described area consists of Five Hundred and Eight (508) Square Metres.

(Portion of 7330/37/50 - 137 Street)

 This By-law may be cited for all purposes as "Portion of 137 Street Road Exchange By-law, 1996, No. 12991."




