WHEREAS, the lands and premises hereinafter described are required for pleasure, recreation or community uses by the City of Surrey (the "City");

shown as:

Remainder Parcel "B" (Reference Plan 4012), North West Quarter, Section 27, Township 8, New Westminster District, SAVE AND EXCEPT that shown within the heavy bold line and containing 0.809 hectares, on a plan of subdivision prepared by Peter M. Mueller, B.C.L.S. on the 9th day of December, 1997, and attached hereto as Schedule A and forming part of this By-law.

(the "Lands")

at or for the total sum of Four Hundred Thousand Dollars (\$400,000), plus any adjustments pursuant to the contract of purchase and sale between the Vendor and the City for the Lands, (the "Purchase Price").

2. Upon the filing for registration, in the New Westminster Land Title Office, a Form A- Freehold Transfer transferring the Lands from the Vendor to the City, the City is hereby authorized to pay to the Vendor the Purchase Price.

3. Upon the transfer of the Lands to the City, the Lands shall be and are hereby declared to be set aside and used for pleasure, recreation, or community uses.

4. The City Clerk is directed to insert the legal description for the Lands in this by-law once title has been issued to the same. The new legal description of the Lands shall be as follows:

Parcel "B" (Reference Plan 4012), Except part subdivided by Plan LMP ______North West Quarter, Section 27, Township 9, New Westminster District.

5. The City Clerk is directed to insert the new civic address for the Lands in this by-law once it has been issued. The new civic address for the Lands shall be as follows:
