CITY OF SURREY

BY-LAW NO. 13369

A by-law to dispose of portions of a public highway in exchange for adjoining lands necessary for a public highway.

WHEREAS pursuant to Section 535 of the *Municipal Act*, R.S.B.C. 1996, c.323, the Council may by by-law dispose of a portion of a highway in exchange for land necessary for the purpose of improving, widening, straightening, relocating or diverting a highway;

AND WHEREAS the Registered Owner of the land described in Section 2 of this By-law has agreed with the City of Surrey to make the exchange hereinafter provided for;

NOW, THEREFORE, the Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

 Upon receiving from the said Registered Owner, the conveyance or other assurance mentioned in Section 2 hereof, the Mayor and the Clerk of the City of Surrey are hereby authorized, in exchange therefore, to execute and deliver on behalf of the City such conveyance or other assurance as may be necessary for vesting in the said Registered Owner, ALL AND SINGULAR those certain parcels or tracts of land and premises situate, lying and being in the City of Surrey, in the Province of British Columbia:

> All that portion of road in Section 16, Township 1, N.W.D., dedicated by Explanatory Plan 15961, shown hatched and designated Parcel F on the Reference Plan, a copy of which is attached hereto, duly signed by the Mayor and Clerk, and was prepared by Allan Olsen, B.C.L.S., dated March 18, 1998, and containing 720 square metres.

(Portion of 138A Street)

2. For the purpose of acquiring adjacent lands for a public highway, the Mayor and Clerk are authorized to accept from the said Registered Owner, in exchange for the land mentioned in Section 1 hereof, the sum of Four Thousand and Seven Hundred Dollars (\$4,700.00), together with such conveyance or other assurance as may be necessary to vest in the Crown as a public highway, ALL AND SINGULAR those certain parcels or

tracts of lands and premises situate, lying and being in the City of Surrey, in the Province of British Columbia:

All that portion of Lot 19, Section 16, Township 1, Plan 7336, shown within the heavy outline and designated Parcel A on the Reference Plan, a copy of which is attached hereto, duly signed by the Mayor and Clerk, and was prepared by Allan Olsen, B.C.L.S., dated March 18, 1998, and containing 247 square metres;

(Portion of 2091 - 140 Street)

All that portion of Parcel A (336696E) Lot 20, Section 16, Township 1, Plan 7336, shown within the heavy outline and designated Parcel B on the Reference Plan, a copy of which is attached hereto, duly signed by the Mayor and Clerk, and was prepared by Allan Olsen, B.C.L.S., dated March 18, 1998, and containing 121 square metres;

(Portion of 2069 - 140 Street)

All that portion of the South 1/2 Lot 20, Section 16, Township 1, Plan 7336, shown within the heavy outline and designated Parcel C on the Reference Plan, a copy of which is attached hereto, duly signed by the Mayor and Clerk, and was prepared by Allan Olsen, B.C.L.S., dated March 18, 1998, and containing 121 square metres;

(Portion of 2053 - 140 Street)

All that portion of Lot 32, Plan 27389, Except Parcel A (Bylaw Plan LMP1816), Section 16, Township 1, Plan 27389, shown within the heavy outline and designated Parcel D on the Reference Plan, a copy of which is attached hereto, duly signed by the Mayor and Clerk, and was prepared by Allan Olsen, B.C.L.S., dated March 18, 1998, and containing 89 square metres; and

(Portion of 2031 - 140 Street)

All that portion of Lot 32, Plan 23789, Except Parcel A (Bylaw Plan LMP1816), Section 16, Township 1, Plan 27389, shown within the heavy outline and designated Parcel E on the Reference Plan, a copy of which is attached hereto, duly signed by the Mayor and Clerk, and was prepared by Allan Olsen, B.C.L.S., dated March 18, 1998, and containing 50 square metres.

(Portion of 2031 - 140 Street)

 This By-law may be cited for all purposes as "Portion of 140 Street and 20 Avenue Road Exchange By-law, 1998, No. 13369."
