## CITY OF SURREY

### BY-LAW NO. 13620

A by-law to dispose of portions of a public highway in exchange for adjoining lands necessary for a public highway.

WHEREAS pursuant to Section 535 of the <u>Municipal Act</u>, R.S.B.C. 1996, c.323, as amended, the Council may by by-law dispose of a portion of a highway in exchange for land necessary for the purpose of improving, widening, straightening, relocating or diverting a highway;

AND WHEREAS the Registered Owner of the land described in Section 2 of this By-law has agreed with the City of Surrey to make the exchange hereinafter provided for;

NOW, THEREFORE, the Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

 Upon receiving from the said Registered Owner, the conveyance or other assurance mentioned in Section 2 hereof, the Mayor and the Clerk of the City of Surrey are hereby authorized, in exchange therefore, to execute and deliver on behalf of the City such conveyance or other assurance as may be necessary for vesting in the said Registered Owner, ALL AND SINGULAR those certain parcels or tracts of land and premises situate, lying and being in the City of Surrey, in the Province of British Columbia:

> That portion of road dedicated by Plan 1378 lying in Section 15, Township 2, New Westminster District, shown hatched on Reference Plan attached hereto and forming a part of this by-law, duly signed by the Mayor and Clerk, prepared by Scott E. Netherton, B.C.L.S. on the 26th day of November 1998, and containing 991 square metres, and called Parcel 'A'.

> > (Portion of Hyland Road Between 146 and 148 Streets)

2. For the purpose of acquiring adjacent lands for a public highway, the Mayor and Clerk are authorized to accept from the said Registered Owner, in exchange for the land mentioned in Section 1 hereof, the sum of One Dollar (\$1.00), together with such conveyance or

other assurance as may be necessary to vest in the Crown as a public highway, ALL AND SINGULAR those certain parcels or tracts of lands and premises situate, lying and being in the City of Surrey, in the Province of British Columbia:

Those portions of Section 15, Township 2, New Westminster District, shown outlined in heavy black line on Reference Plan attached hereto and forming a part of this by-law, duly signed by the Mayor and Clerk, prepared by Scott E. Netherton, B.C.L.S. on the 26th day of November 1998, and described as follows:

That Portion of Parcel Identifier: 023-732-105, Lot 'E' (See BL 127609), Section 15, Township 2, New Westminster District, Plan 1378 and containing 161 square metres and called Parcel 'C'; and

(Portion of 14701 - 64 Avenue)

That portion of Parcel Identifier: 000-824-518, Lot 45, Section 15, Township 2, New Westminster District, Plan 1378 and containing 80 square metres, and called Parcel 'B'.

(Portion of 14703 - 64 Avenue)

 This By-law may be cited for all purposes as "Portion of 64 Avenue Road Exchange By-law, 1998, No. 13620."






