## BY-LAW NO. 14834

A by-law to dispose of portions of a public highway in
exchange for adjoining lands necessary for a public highway

WHEREAS pursuant to Section 525(3) of the *Local Government Act*, R.S.B.C. 1996, c.323, as amended, the Council may by by-law dispose of a portion of a highway in exchange for land necessary for the purpose of improving, widening, straightening, relocating or diverting a highway;

AND WHEREAS the Registered Owner of the land described in Section 2 of this By-law has agreed with the City of Surrey to make the exchange hereinafter provided for;

NOW, THEREFORE, the Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Upon receiving from the said Registered Owner, the conveyance or other assurance mentioned in Section 2 hereof, the Mayor and the Clerk of the City of Surrey are hereby authorized, in exchange therefore, to execute and deliver on behalf of the City such conveyance or other assurance as may be necessary for vesting in the said Registered Owner, ALL AND SINGULAR those certain parcels or tracts of land and premises situate, lying and being in the City of Surrey, in the Province of British Columbia:

Those Portions of Road lying in Section 9 Block 5 North Range 2 West New Westminster District, dedicated by Plan 480, shown hatched on a Reference Plan attached hereto, duly signed by the Mayor and Clerk, prepared by Alan J. Zacharias, B.C.L.S. on the 17th day of October, 2002, and described as follows:

That portion of road containing 0.330 hectares and called Parcel A:

(Portion of 113A Avenue)

That portion of road containing 0.265 hectares and called Parcel B:

(Portion of 113B Avenue)

That portion of road containing 695 square metres and called Parcel C:

(Portion of 114 Avenue)

That portion of road containing 725 square metres and called Parcel D:

(Portion of 115A Avenue)

That portion of road containing 0.335 hectares and called Parcel E:

(Portion of 114A Avenue)

That portion of road containing 0.329 hectares and called Parcel F:

(Portion of 114 Avenue)

That portion of road containing 0.335 hectares and called Parcel G:

(Portion of 114 Avenue)

That portion of road containing 0.166 hectares and called Parcel H:

(Portion of 113B Avenue)

That portion of road containing 0.441 hectares and called Parcel I:

(Portion of 130 Street)

2. For the purpose of acquiring adjacent lands for a public highway, the Mayor and Clerk are authorized to accept from the said Registered Owner, in exchange for the land mentioned in Section 1 hereof, the sum of One Dollar (\$1.00), together with such conveyance or other assurance as may be necessary to vest in the Crown as a public highway, ALL AND SINGULAR those certain parcels or tracts of lands and premises situate, lying and being in the City of Surrey, in the Province of British Columbia:

Those portions of land lying in Section 9 Block 5 North Range 2 West New Westminster District, shown outlined in heavy black line on a Reference Plan attached hereto, duly signed by the Mayor and Clerk, prepared by Alan J. Zacharias, B.C.L.S. on the 17th day of October, 2002, and described as follows:

That portion of Parcel Identifier: 001-314-521 Lot A (Y36283) Block 15 Section 9 Block 5 North Range 2 West New Westminster District Plan 480, containing 0.160 hectares and called Parcel J:

That portion of Parcel Identifier: 001-314-556 Lot A (Y36284) Block 16 Section 9 Block 5 North Range 2 West New Westminster District Plan 480, containing 0.104 hectares and called Parcel K:
