

THE CORPORATION OF THE DISTRICT OF SURREY

BY-LAW NO. 11092

A by-law to reopen portions of highways in Ocean Park, namely 15 Avenue, 128A Street, 129 Street, 129B Street and 130 Street which have been stopped up and closed to traffic.

WHEREAS the Municipal Council of The Corporation of the District of Surrey may by By-law reopen a highway or portion of it which has been stopped up and closed to traffic, pursuant to Section 578(1) of the Municipal Act, R.S.B.C. 1979 Chapter 290.

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

(a) That portion of Fifteen (15) Avenue in the North-East Quarter of Section Seven (7), Township One (1), Plan Two Thousand Eight Hundred Thirty-Four (2834), New Westminster District, as shown outlined red on By-law Plan attached hereto and prepared by R.J. Gregory, B.C.L.S., on September 15, 1976, and containing 0.516 acres (formerly 15 Avenue);

(b) Those portions of road in the fractional North-West Quarter of Section Eight (8), Township One (1), Plan Two Thousand Eight Hundred Thirty-Four (2834), New Westminster District, as shown outlined red on By-law Plan attached hereto and prepared by R.J. Gregory, B.C.L.S., on September 15, 1976, and containing 0.268 acres (formerly 128A Street), 0.358 acres (formerly 129 Street), and 0.402 acres (formerly 129B Street) respectively;

(c) That portion of road in the fractional North-West Quarter of Section Eight (8), Township One (1), Plan Two Thousand Eight Hundred Thirty-Four (2834), New Westminster District, as shown outlined red on By-law Plan attached hereto and prepared by R.J. Gregory, B.C.L.S., on September 15, 1976, and containing 8151 square feet (formerly a portion of 130 Street);

AND

That portion of road in the fractional North-West Quarter of Section Eight (8), Township One (1), Plan Two Thousand Seven Hundred Fifteen (2715), New Westminster District, as shown outlined red on By-law Plan attached hereto and prepared by R.J. Gregory, B.C.L.S., on September 15, 1976, and containing 7959 square feet (formerly a portion of 130 Street)

which said By-law Plans are attached hereto and form part of this By-law as Schedule "A" (hereinafter referred

to as "Portion of 15 Avenue, 128A Street, 129 Street, 129B Street and 130 Street", shall be and are hereby declared to be reopened as highways open to traffic.

2. "Ocean Park Road Ends Road Closing By-law, 1977, No. 5318" is hereby repealed.
3. This By-law may be cited for all purposes as "Ocean Park Road Ends Highway Reopening By-law, 1991, No. 11092."
