BY-LAW NO. 13586

A by-law to stop up and close a portion of
unopened road bounded by 83 Avenue,
Harvie Road, and 184 Street
.....

WHEREAS the Council of the City of Surrey, pursuant to Section 541 of the Municipal Act, R.S.B.C. 1996, c.323, may by by-law, stop up and close to traffic a highway or any portion of a highway;

NOW, THEREFORE, the Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Portion of Parcel Identifier: 013-231-707, Parcel B (Reference Plan 34777) North Half of the South West Quarter Section 28 Township 8 New Westminster District as shown within the bold outline on a Reference Plan certified correct by W.G. Lammerts, B.C.L.S., on the 30th day of September, 1998, having an area of 0.603 hectares (6030 square metres) and called Parcel "A", a copy of said Reference Plan attached hereto and forming a part of this By-law, is hereby stopped up and closed to traffic.

(Unopened Road Bounded By 83 Avenue, Harvie Road, And 184 Street)

2. This By-law may be cited for all purposes as "83 Avenue/Harvie Road/184 Street Road Closing By-law, 1998, No. 13586."

PASSED THREE READINGS on the 23rd day of November, 1998.

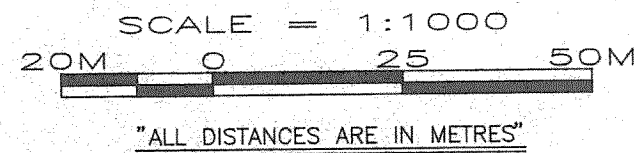

INTEGRATED SURVEY AREA NO. 1

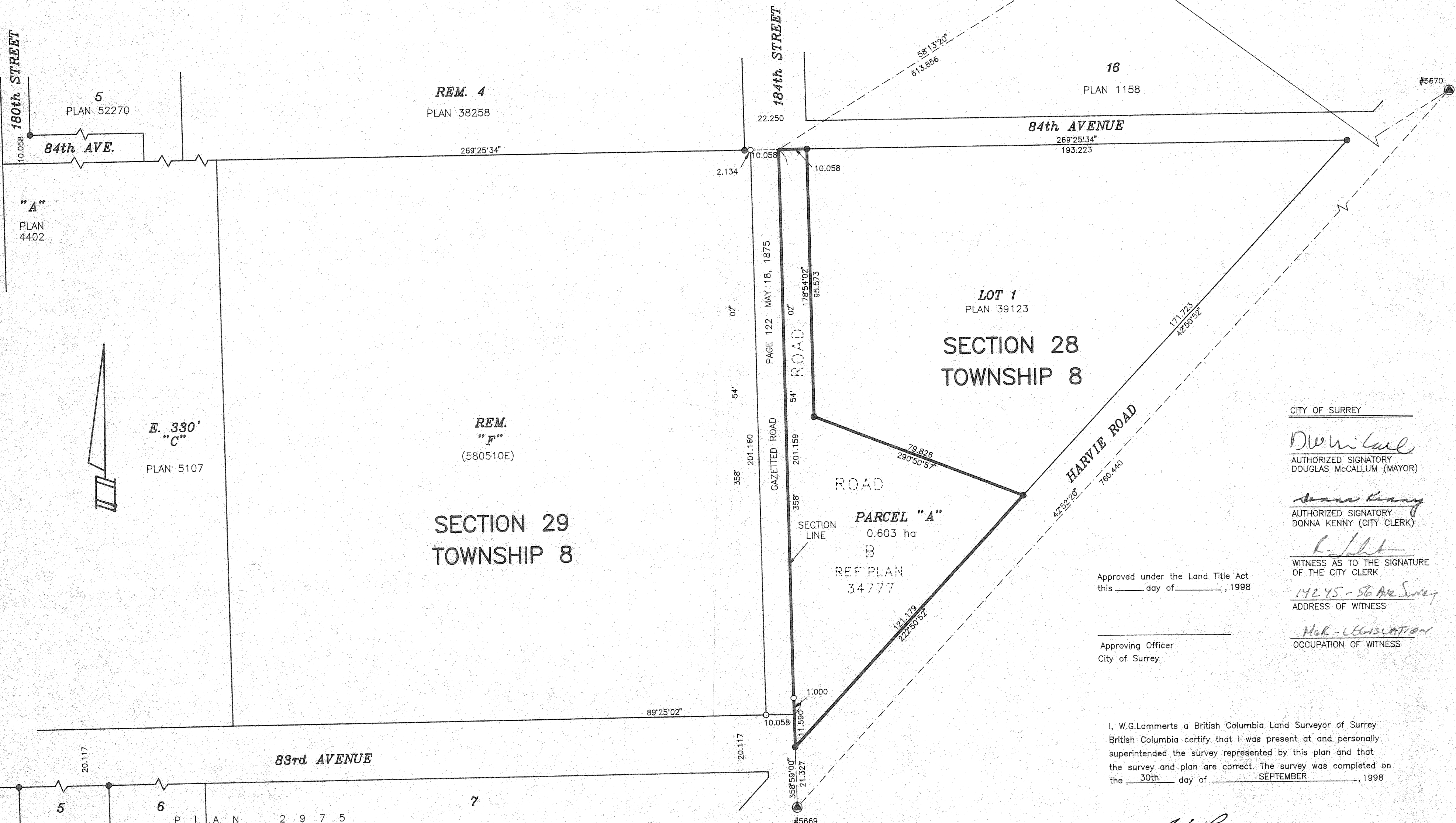
