BY-LAW NO. 14064

A by-law to stop up and close a portion of
145A Street from 72 Avenue to 72A Avenue.

WHEREAS the Council of the City of Surrey, pursuant to Section 527(1) of the *Local Government Act*, R.S.B.C. 1996, c.323, as amended, may by by-law, stop up and close to traffic a highway or any portion of a highway;

NOW, THEREFORE, the Council of the City of Surrey, in open meeting assembled,
ENACTS AS FOLLOWS:

1. 145A Street, at a line commencing at the northeasterly corner of Lot 6 Except: Parcel A (By-law Plan 83129) Section 22 Township 2 New Westminister District Plan 21221.

Thence easterly on said line to the northwesterly corner of Lot 76 Section 22 Township 2 New Westminister District Plan 46213.

Said line shown heavy dashed on sketch attached hereto.

(145A Street along the South Side of 72A Avenue);

145A Street, at a line commencing at the southeasterly corner of Lot 6 Except: Parcel A (By-law Plan 83129) Section 22 Township 2 New Westminister District Plan 21221.

Thence easterly on said line to the southwesterly corner of Lot 76 Section 22 Township 2 New Westminister District Plan 46213.

Said line shown heavy dashed on sketch attached hereto.

(145A Street along the North Side of lane south of 72A Avenue);

145A Street, at a line commencing at the northeasterly corner of Lot 5 Except: Parcel B (By-law Plan 83129) Section 22 Township 2 New Westminister District Plan 21221.

Thence easterly on said line to the northwesterly corner of Lot 77 Section 22 Township 2 New Westminister District Plan 46213.

Said line shown heavy dashed on sketch attached hereto.

(145A Street along the South Side of lane south of 72A Avenue); and

145A Street, at a line commencing at the southeasterly corner of Lot 5 Except: Parcel B (By-law Plan 83129) Section 22 Township 2 New Westminster District Plan 21221.

Thence easterly on said line to the southwesterly corner of Lot 77 Section 22 Township 2 New Westminster District Plan 46213.

Said line shown heavy dashed on sketch attached hereto.

(145A Street along the North Side of 72 Avenue).

are hereby stopped up and closed to traffic.

2. This By-law may be cited as "Surrey Stop Up and Close of 145A Street from 72 Avenue to 72A Avenue, By-law, 2000, No. 14064".
