## **CITY OF SURREY**

## BY-LAW NO. 14658

A by-law to stop up and close a portion of King George Highway at 32 Avenue and a portion of 32 Avenue at 148A Street.

WHEREAS the Council of the City of Surrey, pursuant to Section 527(1) of the *Local Government Act*, R.S.B.C. 1996, c.323, as amended, may by by-law, stop up and close to traffic a highway or any portion of a highway;

NOW, THEREFORE, the Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Portions of road shown in bold outline on a Reference Plan attached hereto and forming part of this by-law, duly signed by the Mayor and Clerk, prepared by G.A. Hol, B.C.L.S. on the 5th day of March, 2002, and more particularly described as follows:

That Portion of Road in Section 27 Township 1, New Westminster District, dedicated by Plan LMP39907, containing 0.1 square metre, and called Parcel A:

(Portion of 32 Avenue at 148A Street)

That Portion of Road in Section 27 Township 1, New Westminster District, dedicated by Plan LMP41763, containing 14 square metres, and called Parcel B:

(Portion of 32 Avenue at 148A Street)

That Portion of Road in Section 22 Township 1, New Westminster District, dedicated by Plan LMP48884, containing 91 square metres, and called Parcel C:

(Portion of 32 Avenue at 148A Street)

That Portion of Road in Section 22 Township 1, New Westminster District, dedicated on Right of Way by Plan 5388, containing 118 square metres, and called Parcel D:

(Portion of King George Highway at 32 Avenue)

That Portion of Road in Section 22 Township 1, New Westminster District, dedicated on Plan LMP48884, containing 18 square metres, and called Parcel E:

(Portion of King George Highway at 32 Avenue)

That Portion of Road in Section 27 Township 1 New Westminster District, dedicated on Plan LMP48884, containing 17 square metres and called Parcel F:

(Portion of King George Highway at 32 Avenue)

That Portion of Road in Section 27 Township 1 New Westminster District, dedicated on Right of Way Plan 5388, containing 48 square metres and called Parcel G:

(Portion of King George Highway at 32 Avenue)

is hereby stopped up and closed to traffic.

 This By-law may be cited as "Surrey Stop Up and Close of a Portion of King George Highway at 32 Avenue and a Portion of 32 Avenue at 148A Street By-law, 2002, No. 14658."
