BY-LAW NO. 15257

A By law to close and to remove the dedication  
of a highway of portions of 113 Avenue,  
113A Avenue, 114 Avenue, 114A Avenue,  
154A Street, 156 Street and a portion of Lane  
between 154A Street and 156 Street  
.....

WHEREAS pursuant to Subsection 40(1)(a) of the *Community Charter*, S.B.C. 2003, c. 26,  
the Council may, by by law, close all or part of a highway that is vested in the municipality to all or some types of  
traffic;

AND WHEREAS pursuant to Section 40(2) of the *Community Charter*, S.B.C. 2003, c. 26, the Council may, by  
by law, remove the dedication of a highway that has been closed by a by law under Subsection 40(1)(a).

NOW THEREFORE the Council of the City of Surrey in open meeting assembled, ENACTS as follows:

1. Those portions of road lying in Section 9 Block 5 North New Westminster District shown outlined in heavy  
black line on Reference Plan attached hereto, duly signed by the Mayor and Clerk, prepared by H. David Little,  
B.C.L.S. on the 10<sup>th</sup> day of December, 2003, attached to and forming part of this by law, and more  
particularly described as follows:

That portion of road dedicated by Plan 1816, containing 0.878 hectares and called  
Parcel "C",

That portion of road dedicated by Plan 1718, containing 0.605 hectares and called  
Parcel "B",

That portion of road dedicated by Plan 1718, containing 0.152 hectares and called  
Parcel "A".

(hereinafter referred to as those portions of 113 Avenue, 113A Avenue, 114 Avenue, 114A Avenue,  
154A Street, 156 Street and Lane)

shall be closed to traffic.

2. The dedication as highway be removed of said portions of 113 Avenue, 113A Avenue, 114 Avenue,

114A Avenue, 154A Street, 156 Street and Lane.

3. This By law may be cited for all purposes as "Surrey Close and Remove the Dedication of Highway of a Portion of 113 Avenue, 113A Avenue, 114 Avenue, 114A Avenue, 154A Street, 156 Street and portion of Lane between 154A Street and 156 Street By law, 2004, No. 15257".

READ A FIRST, SECOND AND THIRD TIME on the 26th day of January, 2004.
