AND WHEREAS pursuant to Section 40(2) of the <i>Community Charter</i> , S.B.C. 2003, c. 26, the Council may, by by-law, remove the dedication of a highway that has been closed by a by-law nder Subsection 40(1)(a).
IOW THEREFORE the Council of the City of Surrey in open meeting assembled, ENACTS as ollows:
That portion of road lying in Section 4 Township 9 New Westminster District shown outlined in heavy black line on a Reference Plan attached hereto, and forming part of this by-law, duly signed by the Mayor and Clerk, prepared by Grant Butler, B.C.L.S. on the 7th day of March, 2007, and more particularly described as follows:
That portion of road dedicated by Plan 519, containing 0.443 hectares and called Parcel 1,
(hereinafter referred to as that portion of 189 Street)
shall be closed to traffic.
. The dedication as highway be removed of said portion of 189 Street.
This By-law may be cited for all purposes as "Surrey Close and Remove the Dedication of Highway of a Portion of 189 Street between 96 Avenue and 98 Avenue By-law, 2007, No. 16354".
