### **CITY OF SURREY**

### BY-LAW NO. 16356

A By-law to close and to remove the dedication of a highway of portions of Scott Road and Grace Road.

WHEREAS pursuant to Subsection 40(1)(a) of the *Community Charter*, S.B.C. 2003, c. 26, the Council may, by by-law, close all or part of a highway that is vested in the municipality to all or some types of traffic;

AND WHEREAS pursuant to Section 40(2) of the *Community Charter*, S.B.C. 2003, c. 26, the Council may, by by-law, remove the dedication of a highway that has been closed by a by-law under Subsection 40(1)(a).

NOW THEREFORE the Council of the City of Surrey in open meeting assembled, ENACTS as follows:

1. Those portions of road shown outlined in heavy black line on a Reference Plan attached hereto, and forming part of this by-law, duly signed by the Mayor and Clerk, prepared by David W. Parkin, B.C.L.S. on the 24th day of April, 2007, and more particularly described as follows:

That portion of road dedicated on Plan 5342 District Lot 9 Group 2 New Westminster District, called Parcel A and containing 0.143 hectares,

That portion of Grace Road

That portion of road dedicated on Reference Plan 1833 Section 25 Block 5 North, Range 3 West New Westminster District, called Parcel B and containing 0.169 hectares,

That Portion of Grace Road

That portion of road dedicated on Reference Plan BCP Section 25 Block 5 North Range 3 West New Westminster District, called Parcel C and containing 0.147 hectares,

That portion of Grace Road

That portion of road dedicated by Reference Plan 81385 Section 25 Block 5 North Range 3 West New Westminster District, called Parcel D and containing 118.7 square metres,

That portion of Scott Road

That portion of road dedicated by Reference Plan BCP\_\_\_\_\_\_\_ Section 19 Block 5 North Range 2 West New Westminster District, called Parcel E and containing 897.9 square metres,

# That portion of Scott Road

That portion of road dedicated by Statutory Right of Way Plan LMP22752 Section 19 Block 5 North Range 2 West New Westminster District, called Parcel F and containing 175.0 square metres,

# That portion of Scott Road

That portion of road dedicated by Statutory Right of Way Plan BCP\_\_\_\_\_\_ Section 19 Block 5 North Range 2 West New Westminster District, called Parcel G and containing 551.5 square metres,

That portion of Scott Road

(hereinafter referred to as those portions of road)

shall be closed to traffic.

- 2. The dedication as highway be removed of said portions of road.
- 3. This By-law may be cited for all purposes as "Surrey Close and Remove the Dedication of Highway of Portions of Scott Road (120 Street) and Grace Road By-law, 2007, No. 16356".
