
A By-law to close and to remove the dedication of a highway of a portion of 12B Avenue.
WHEREAS pursuant to Subsection 40(1)(a) of the <i>Community Charter</i> , S.B.C. 2003, c. 26, the Council may, by by-law, close all or part of a highway that is vested in the municipality to all or some types of traffic;
AND WHEREAS pursuant to Section 40(2) of the <i>Community Charter</i> , S.B.C. 2003, c. 26, the Council may, by by-law, remove the dedication of a highway that has been closed by a by-law under Subsection 40(1)(a).
NOW THEREFORE the Council of the City of Surrey in open meeting assembled, ENACTS as follows:
1. That portion of road lying in Section 8, Township 1, New Westminster District, shown outlined in heavy black line on a Reference Plan attached hereto, and forming part of this by-law, duly signed by the Mayor and Clerk, prepared by Montgomery C. Brisson, B.C.L.S. on the 21st day of August, 2008, and more particularly described as follows:
That portion of road dedicated on Plan 2715, called Parcel "A", and containing 409.9 square metres,
(hereinafter referred to as that portion of 12B Avenue)
shall be closed to traffic.
2. The dedication as highway be removed of said portion of 12B Avenue.
3. This By-law may be cited for all purposes as "Surrey Close and Remove the Dedication of Highway of a Portion of 12B Avenue By-law, 2008, No. 16754".
READ A FIRST, SECOND AND THIRD TIME on the 8th day of September, 2008.
NOTICE OF INTENTION ADVERTISED on the 12th and 19th day of September, 2008, in the SURREY NOW newspaper.
RECONSIDERED AND FINALLY ADOPTED, signed by the Mayor and Clerk, and sealed with the Corporate Seal on the 29th day of September, 2008.


