BY-LAW NO. 17277

A By-law to close and to remove the dedication
of a highway of portions of road
.....

WHEREAS pursuant to Subsection 40(1)(a) of the *Community Charter*, S.B.C. 2003, c. 26, the Council may, by by-law, close all or part of a highway that is vested in the municipality to all or some types of traffic;

AND WHEREAS pursuant to Section 40(2) of the *Community Charter*, S.B.C. 2003, c. 26, the Council may, by by-law, remove the dedication of a highway that has been closed by a by-law under Subsection 40(1)(a).

NOW THEREFORE the Council of the City of Surrey in open meeting assembled, ENACTS as follows:

1. That portion of road lying in Section 22, Township 2, New Westminster District, shown outlined in heavy black line on a Reference Plan attached hereto, and forming part of this by-law, duly signed by the Mayor and Clerk, prepared by Eugene O Wong, B.C.L.S. on the 23rd day of September, 2010, and more particularly described as follows:

That portion of road, dedicated by Plan LMP19114, called Parcel A and containing 129.8 square metres,

(hereinafter referred to as that portion of Road)

shall be closed to traffic.

2. The dedication as highway be removed of said portion of Road.
3. This By-law may be cited for all purposes as "Surrey Close and Remove the Dedication of a Portion of 145A Street and 72A Avenue By-law, 2010, No. 17277".

READ A FIRST, SECOND AND THIRD TIME on the 1st day of November, 2010.

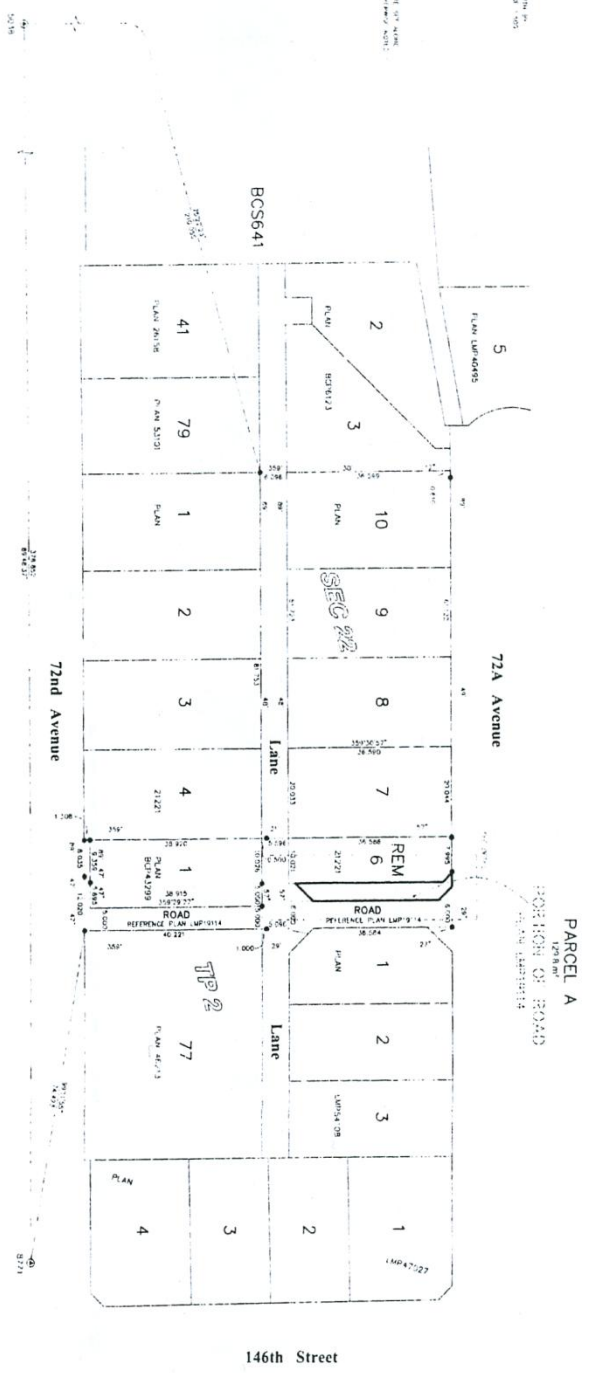

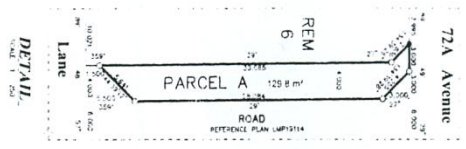
