BYLAW NO. 19780

A Bylaw to close and to remove the dedication  
of a highway of portions of road  
.....

WHEREAS pursuant to Subsection 40(1)(a) of the *Community Charter*, S.B.C. 2003, c. 26, the Council may, by bylaw, close all or part of a highway that is vested in the municipality to all or some types of traffic;

AND WHEREAS pursuant to Section 40(2) of the *Community Charter*, S.B.C. 2003, c. 26, the Council may, by bylaw, remove the dedication of a highway that has been closed by a bylaw under Subsection 40(1)(a).

NOW, THEREFORE the Council of the City of Surrey ENACTS as follows:

1. Those portions of Section 6 Township 9 West New Westminster District shown outlined in heavy black line on Reference Plan EPP87127 attached hereto and forming part of this bylaw, prepared by Eugene Wong, B.C.L.S. on the 31st day of January, 2019, and described as follows:

that portion of unconstructed road allowance dedicated by Plans EPP4727, EPP4730 and EPP4731, containing 0.118 hectares and labeled as Parcel 1;

that portion of road allowance dedicated by Plans EPP4729, EPP4730, EPP89511 and EPP13306, containing 0.318 hectares and labeled as Parcel 2;

(hereinafter referred to as that portion of Road)

shall be closed to traffic.

2. The dedication as highway be removed of said portions of Road.
3. This Bylaw may be cited for all purposes as " Surrey Close and Remove the Dedication of Highway of a Portion of Road adjacent to 10035 - 176 Street, 17524, 17539 and 17570 - 100 Avenue Bylaw, 2019, No. 19780".

PASSED THIRD READING on the 11th day of February, 2019.

RECEIVED APPROVAL FROM THE MINISTRY OF TRANSPORTATION AND INFRASTRUCTURE on the 20th day of February, 2019.
