## RECOMMENDATION

That Contract M.S. 4704-002 be awarded to the low bidder, Pedre Contractors Ltd., in the amount of \$1,176,893.00 including GST.

## SCOPE OF WORK

Contract M.S. 4705-004 is a construction package grouping five sanitary sewer relief projects and the installation of an emergency overflow storage for Elgin Sewage Pump Station, as follows:

Pedre has no outstanding claims or legal issues with Surrey. In line with standard procedures, we will monitor and assess their performance in this contract very closely for future tender evaluation. We recommend Pedre contractors Ltd. be awarded this contract.
