SUBJECT: Contract Award MS 1705-019-11
2005 Miscellaneous Road Works

RECOMMENDATIONS

1. That Council set the expenditure authorization for 2005 Miscellaneous Road Works Contract M.S. 1705-019-11 to \$3,014,005.00 (including GST);
2. That Contract M.S. 1705-019-11 be awarded to Imperial Paving Ltd. in the amount of \$2,870,480.90 (including GST); and
3. That Council approve an additional allocation of \$247,100 from the Parks DCC Program to fund the park related road works.

Scope of Work

The scope of work under this contract involves miscellaneous road works at various locations throughout the City of Surrey including off-street bicycle core network, intersection improvements, traffic calming, sidewalk construction, minor transit improvements and street lighting.

Construction is expected to start in early January and be completed by the fall of 2006.

Tender Results

Tenders for Contract M.S. 1705-019-11 were received on November 15, 2005, with the results as follows:

The Engineer's pre-tender estimate was \$2.7 million (including GST).

Evaluation

Our consultant reviewed all tenders. All the tenders submitted the required 10% bid bond, and signed and sealed the Form of Tender.

The low bidder, Imperial Paving Ltd., has provided a "Consent of Surety - Performance Bond and Labour & Materials" and agreed to complete the work within 150 working days as stipulated in the contract.

Imperial Paving Ltd. has no outstanding claims or legal issues with Surrey and has satisfactorily completed many similar contracts for the City in the past. We recommend Imperial Paving Ltd. be awarded this contract.

Funding

Funding for this project is provided within the City's Transportation, Utilities and Parks budgets. One of the components of the works, a park frontage on 146 Street at 58 Avenue, does need additional funding to cover cost escalation since the original funding was allocated.
