SUBJECT:	Local Area Service Water Main Extension 168 Street from 40 Avenue to 48 Avenue		

RECOMMENDATIONS

The Engineering Department recommends that Council:

- 1. Establish a Local Area Service (LAS) Watermain Extension to provide water supply to the properties on 168 Street from 4843 to 16830, and on 40 Avenue from 168 Street to 4136, as formally petitioned, for an estimated cost of \$577,000 for all the properties within the benefiting area. The costs will be 100% recovered by the local service tax and will be apportioned by the frontage of each property in accordance with the Local Area Service Policy R-6, when final costs are determined.
- 2. Introduce for adoption the corresponding Local Area Service By-law.

INTENT

To fulfill petitioners' request for a water main extension.

DISCUSSION

Property owners on 168 Street from 4843 to 16830 and on 40 Avenue from 168 Street to 4136 (see attached sketch) have petitioned Council to extend the water distribution system. The petition has been certified to be 'sufficient' in accordance with the Community Charter. (A copy of the City Clerk's certificate is attached.)

The costs of the watermain extension have been estimated at \$577,000.00 and will be shared among the properties within the benefiting area based on the frontage of each property as per the City's Local Area Service Policy.

There are sufficient funds in the Water Capital LAS Program to cover the costs for the private properties within the LAS benefiting area.
