## RECOMMENDATIONS

The Engineering Department recommends that Council:

1. Award Contract M.S. 1706-018 to Aggressive Roadbuilders Ltd. in the amount of \$873,664.72, including GST; and
2. Set the expenditure authorization for Contract M.S. 1706-018 at \$917,000.00, including GST.

## SCOPE OF WORK

The scope of work includes traffic calming at 11 locations and repaving at one location prior to speed hump installation and various other road work. Some of this roadwork is considered as provisional within the terms of this contract award.

Our consultant reviewed the tenders for accuracy and completeness. No errors were found. All submissions included the required 10% bid bond, and were signed and sealed on the Tender Form and Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Aggressive Roadbuilders Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 50 working days as stipulated in the contract. Aggressive's past performance on similar work has been satisfactory and they have no outstanding legal claims against the City. We, therefore, recommend that Aggressive Roadbuilders Ltd. be awarded the work.
